- b. The Chief Education Officers before implementing the Order, shall satisfy themselves about the genuineness of qualification/degree certificates and ensure that the official(s) has/have qualified if any course/degree during in-service has/have obtained prior permission from the competent authority or as per Circulars/ instructions/ Orders/ Notifications issued by the Competent Authority at the relevant point of time.
- c. The confirmation so accorded is without pre-judice to the outcome of Writ Petition(s), if any, pending before Competent Court of Law, which is not immediately within the knowledge of this Directorate.
- d. Latest Vigilance Clearance Certificate in respect of each such official.
- e. Last 03 years satisfactory APRs.
- f. That the official must necessarily be holding genuine appointment on substantive basis, in the department and has been appointed/ selected by the Competent Authority and has uninterrupted service, and shall not fall in the category of Fake, Fraud, Adhoc/Contractual appointment/ Migrant substitute and there is nothing adverse against the official(s) from VOK/Crime/ Police or any other agency.



- g. The benefit of confirmation shall not be allowed in case of such official(s) who is/are either under suspension or whose suspension period is still undecided or against whom the departmental/VOK proceeding is presently pending.
- h. Satisfactory Integrity/ Work & Conduct Certificate from the concerned Drawing and Disbursing Officer.
- i. Good Result percentage of the subjects taught by the official(s).
- l. An affidavit duly executed before 1<sup>st</sup> Class Magistrate, to the effect that there is no Court case, investigation whatsoever nature pending before the Department or any investigating agency against the official(s).
- j. The in-situ promotion availed by the official(s) during their tenure in the Department shall also be withdrawn, if they fails to avail the placement as laid down under Rule 10 of SRO-14 dated 15-01-1996.
- k. Up-dated service verification certificate of each official.


