Sub: Promotion of Trained Graduate/Post-Graduate Teachers as Masters and cancellation of promotion thereof.

ORDER NO. 285 DSEK OF 2023 DATED 28 /10/2023

Whereas, vide this office Order No. 267 DSEK of 2023 dated 17-10-2023, **304** eligible trained graduate/post-graduate teachers on the basis of feedback/documents/certificates provided by the respective Chief Education Officers have been promoted as Masters, in terms of SRO 375 of 2010 dated 21-10-2010 with certain terms and conditions; and

Whereas among others, **09 Teachers** have obtained **Moalim-e-Urdu** through Jamai Urdu Aligarh, previously declared as equivalent as Bachelor of Education (B.Ed.) Degree awarded by State Universities of Jammu and Kashmir by the Higher Education Department vide Govt. Order No. 140/HE of 2017 dated 08-03-2017 have also been promoted as Masters; and

Whereas, after issuance of the said Order, it has been brought into the notice of this office that these 09 Teachers have obtained **Moalim-e-Urdu** through Jamai Urdu Aligarh officials, who were erroneously been included in the said Promotion Order on the grounds that the Higher Education Department vide order No. 231 JK(HE) of 2023 dated 21-08-2023 has withdrawn the aforementioned equivalence order, abinitio; and

Whereas, in addition to above, the Chief Education officer Kulgam vide his No. CEO/K/Estt/6156/23 dated 19-10-2023 has communicated that **Mtr. Shazia Rasool**, Teacher GMS Kulgam appearing at S.No. 20 in the said Promotion Order has qualified her B.Ed. Degree Course on **31-05-2023**, i.e after the date of conduct of the Divisional Promotion committee meeting; viz 24/07/2022; and

Now, therefore, the Promotion order issued vide this Office Order No. 267-DSEK of 2023 dated 17-10-2023 is hereby rescinded so far as it pertains to the following **10 officials** appearing at the Serial No./Annexures of the Order as indicated against each, ab-initio:-
