The placement of these In-charge Head Assistant shall be subject to the fulfillment of following explicit conditions:

The above arrangement is temporary and shall not confer any preferential right upon the aforementioned official to hold the post on substantive basis or claim placement as Head Assistant, as and when the same is considered on regular basis in accordance with the rules.

2) The benefit of placement shall not be allowed in case of such official(s) who is/are either under suspension or whose suspension period is still undecided or against whom the departmental/V0K proceeding is presently pending or whose work and conduct may not be satisfactory.

3) If the Senior Assistant as named above of this Order, on subsequent verification, is found not eligible for such placement, this order will not confer any right on him and his placement on the higher post (made hereby) shall liable to be rescinded, ab-initio.

- 4) It shall be the personal responsibility of the Chief Education officer/Drawing and Disbursing Officers to verify particulars of the official with reference to his original service records/selection lists/appointment/placement orders and ensure that the date of Ist appointment order/placement/promotion as Junior Assistant/ Senior Assistant/ Date of Birth and vacancies, as well as other particulars recorded against him (herewith in the placement Order) are correct. Variation if any found, should be immediately brought into the notice of this Directorate for further orders and in that case, no such Senior Assistant shall be relieved for their placement on the higher post until further clarification/instructions in the case is sought from this Directorate.
- 5) That the official must necessarily be holding genuine appointment on substantive basis and uninterrupted service, and shall not fall in the category of fake, fraud, adhoc/contractual appointment/migrant substitute.
- 6) The Chief Education officers/ Drawing and Disbursing officers must ensure that there is nothing adverse against the official from VOK/Crime/Police.
- 7) Superior claim vis-a-vis inter-se-placement of the officials for redetermination of inter-se seniority in the cadre of Senior Assistants, if any noticed in terms of **Rule 24 of** CCA **Rule of 1956** be submitted to this Directorate within a period of one month through proper channel.

Consequent upon above, Mr. Parvaiz Ahmad Khaki, Senior Assistant, drawing salary against the post of Head Assistant in Zonal Education Office Mattan, shall now draw his salary against the post of Senior Assistant, which became available due to placement of Abid Ibrahim, Senior Assistant as I/c Head Assistant.

The Chief Education officer/Drawing and Disbursing officer shall implement the order after fulfillment of all conditions as laid down in the placement order and after ensuring that the official has been appointed in the Department by the competent authority on the substantive post, free from all encumbrances.
