Whereas; the recommendation in respect of the said selectee was kept withhold and was subject to production of bonafide certificate/ validity of Graduation (B.Sc.IT); and

Whereas; the withheld recommendation has been released by the Secretary J&K Service Selection Board Jammu vide letter SSB/Secy/Sel/63/2018/2956-58 dated 22/03/2018; and

. Whereas; on perusal of select list it was observed that date mentioned below the signatures of Secretary J&K Service Selection Board in "Annexure A" is 19/02/2018 while as the letter which bears no signatures of Secretary SSB indicates date as 17/02/2018; and

Whereas; the matter was taken-up with the Administrative Department vide this office letter No. DSEK/NT/SSB/558/2018/Kul/908 dated 02/07/2018, followed by series of reminders vide No. DSEK/NT/SSB/558/2018/Kul/1449 dated 25/09/2018, No. DSEK/NT/SSB/558/2018/Kul/430 dated 06/03/2019, No. DSEK/NT/SSB/558/2018/Kulgam/667-668 dated 19/05/2021 and No. DSEK/NT/SSB/558/2018/Kulgam/1525-26 dated 29/09/2021 for conveying necessary instructions/clarification with regard to discrepancies of unmatched dates and unsigned letter from J&K Service Selection Board Jammu; and

Whereas; the Administrative Department vide letter No. Edu-NG K/279/202101 dated 03/01/2022 has forwarded Secretary J&K Service Selection Board's letter No. SSB/Secy/Sel/K/63/18/7869-71 dated 23/11/2021 alongwith its enclosures (i.e. dully singed and attested copy of J&K Service Selection Board's communication dated 17/02/2018 and "Annexure A" of it) and;

Whereas; this Directorate vide letter No. DSEK/NT/SSB/558/2018/Kul/221 dated 24/01/2022 followed by reminder vide letter No. DSEK/NT/SSB/558/2018/Kul/786 dated 26/03/2022, has taken-up the matter with the Administrative Department with regard to revalidation of selection list and;

Whereas, in response to this Directorate letter No. DSEK/Estt/III/B-Trs/SRO/202/2019/3467 dated 08/02/2022 with regard to posts referred to recruiting agencies prior to 31/10/2019 and issuance of appointment orders thereof, the Administrative Department vide letter No. Edu-GEN/137/2022-01-SED dated 29/03/2022 has forwarded the General Administration Department's O.M.No. GAD-MTG0RBIV/200/2021-09-GAD dated 22/03/2022 which among others authorises the issuance of appointment order in respect of the said Librarian after ensuring that:-

- 1. The post(s) against which order(s) are to be issued should be free from all encumbrances.
- 2. There are no Court interventions/orders etc.
- 3. All other terms and conditions for issuance of appointment orders issued by Government from time to time shall be followed.
- 4. If any of the above select lists/recommendations have lost validity owing to delay in issuance of appointment orders/other procedural delays, one-time relaxation is also granted with the directions to concerned Department to issue appointment orders within a period of one month from the date of issuance of this communication.

Now therefore, in view of the above facts, sanction is hereby accorded to the temporary appointment of below named "Librarian" in the pay Level-6 (35400-112400) under SC category in *District cadre Kulgam (item No. 173 against notification No.02 of 2013 dated 16/02/2013)*

The appointee shall report to this Directorate within a period of 21 days from the date of issuance of appointment order. In case the appointee fails to join within the stipulated period his appointment as such shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on production of the following documents/certificates in original.

- 1. Academic/Technical Qualification certificates.
- 2. Matriculation/Date of Birth certificates.
- 3. Health Certificate issued by Chief Medical Officer.
- 4. Domicile Certificate issued by the Competent Authority
- 5. Certificate from the concerned authorities to the effect that no loan under the self employment or any other scheme has been taken by the appointee concerned.
- 6. SC Category certificate

The appointment of the above candidate shall further be subject to the following conditions:-

- 1. Appointee shall give an undertaking duly sworn in before Judicial Magistrate First Class to the effect that in case an adverse report about his verification of academic/technical/category certificate is received from issuing authorities and if his adverse report of character and antecedents is received from Addl. DGP (CID) to whom a reference shall be made by the Department once the appointee join this Directorate is received he shall have no right to claim the appointment as Librarian and in that eventuality appointment order issued shall be deemed to have been cancelled abinitio and no further notice shall be given.
- Salary of the appointee shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K and verification of relevant certificate/documents is received from the concerned issuing authorities.
- The appointment of the candidates as "Librarian" shall be subject to outcome of the writ petition(s) if any pending in any Court of law, which may not be immediately within the knowledge of this Directorate.
- 4. The inter-se seniority of the appointee shall be in the order of merit of the J&K Service Selection Board;
- 5. The appointee shall be on probation for a period of 02 years.
