Whereas, vide SSB's Order No. 465-SSB of 2015, dated 05.10.2015, the selection in respect of Waheed Ahmad Khan S/o Lt. Amir-ullah Khan R/o Azadpora Boniyar, Baramulla has been released with some change in merit position owing to his M.Phil from CMJ University;

Whereas, the said degree (M.Phil) is not coming under the purview of Govt. order No. 252-HE of 2012 dated 30.05.2012, as such Two points from his overall meritwere deducted. Consequently, Waheed Ahmad Khan S/o Lt. Amir-ullah Khan R/o Azadpora Boniyar, Baramulla shall now move from S.No. 43/RBA of Item 447 (05 of 2013)toS.No. 28 under RBA Category (Item 401 of Notification 06 of 2013) with revised merit position of 61.0880

Whereas, the Administrative Department in their earlier communication No. Edu-I/286/2012 dated: 05.09.2012 conveyed guidelines to issue the provisional appointment orders in favour of the selectees after obtaining the undertaking on the devised format with the following explicit conditions:-

The salary in favour of the selected candidates is only drawn:-

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed).
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.

Whereas, in light of above instructions of the Administrative Department, Waheed Ahmad Khan S/o Lt. Amir-ullah Khan R/o Azadpora Boniyar, Baramulla furnished his undertaking on the devised format duly attested by the 1st Class Magistrate alongwith original testimonials in response to this office notification No. Estt-III/B-Trs/67022-25 dated 30.11.2015;



Now, therefore, sanction is hereby accorded to the provisional appointment of Waheed Ahmad Khan S/o Lt. Amir-ullah Khan R/o Azadpora Boniyar, Baramulla as Teacher District Cadre

Baramullaagainst the available slot in RBA category in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under–Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidate is required to report to the Chief Education Officer, Baramulla by or before 17th December, 2015 for further posting.
