The appointment of the candidate shall further be subject to the following conditions:

- that she shall give an undertaking in the shape of an affidavit to the effect that "If, on verification, genuineness of the qualification certificates and other certificates/documents from the concerned issuing authority is found fake/forged, the appointment made shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her."
- the salary of the appointee shall not be drawn and disbursed to her, unless a satisfactory report in respect of (i) above are received in her favour from the issuing authority.

the appointee shall be initially on probation for a period of two years.

- if the appointee fails to join within a period of 21 days from the date of issuance of this order she shall cease her right of appointment which shall be deemed to have been cancelled ab-initio without any further notice.
