Whereas, the Administrative Department vide communication No. Edu/92/2021-01 dated 04.01.2022, No. Edu/95/2021-01-SED dated 21.01.2022 and No. Edu/NG K/23/2022-01-SED dated 14.02.2022 forwarded above referred communications of JKSSB whereunder recommendations were released in respect of Three candidates for the post of "Urdu/Science-Math/General Teacher" respectively; and

Whereas, the Administrative Department vide communication No. Edu-GEN/137/2022-01-SED dated 29.03.2022 forwarded General Administration Department's OM No. GAD-MTG0RBIV/200/2021-09-GAD dated 22.03.2022 whereunder approval has been conveyed for issuance of appointment orders in respect of Four candidates for the post of Teacher within a period of one month from the date of issuance of OM. Dated 22.03.2022; and

Whereas, in respect of one candidate verification of character and antecedents was received from the concerned agency and accordingly appointment order was issued in her favour vide this office Order dated 15.04.2022; and

Whereas, in respect of Three candidates, character and antecedents report has been sought from the Criminal Investigation Department by this office in pursuance to Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021, which is yet to be received; and

Whereas, to comply the instructions of the General Administration Department's OM dated 22.03.2022, appointment order needs to be issued within a period of one month as such there is no alternative but to issue appointment orders in anticipation of their character and antecedents report from the Criminal Investigation Department; and

Now, therefore, pursuant to the instructions of General Administration Department's OM No. GAD-MTG0RBIV/200/2021-09-GAD dated 22.03.2022, conveyed by Administrative Department vide communication No. Edu-GEN/137/2022-01-SED dated 29.03.2022, sanction is hereby accorded to provisional appointment of following Three candidates as "Urdu/Science-Math/General Teacher" in District Cadre shown against each in the minimum of Pay Level 5 (Rs. 29,200-92,300/-), as admissible under SRO-193 of 2018, dated 24.04.2018 under SRO-202 of 2015 dated 30.06.2015 as amended vide S.O. 194 dated 17.06.2020, subject to satisfactory report of their character and antecedents from the competent authority:-

The conditions of probation, pay and allowances and fixation of initial tenure of the appointees shall be governed by Jammu & Kashmir Probationer (Condition of Service, Pay & Allowances) and Fixation of Tenure Rules 2020 issued vide S.O. 192 of 2020 dated 17.06.2020 read with Government Order No. 654-JK (GAD) of 2020 dated 19.06.2020.

The appointee shall report to Chief Education Officer concerned within a period of 21 days from the date of issuance of this appointment order and shall be allowed to join only after production/submission of following documents/certificates in original to be verified subsequently:

- i. *Academic Qualification Certificates*
- ii. *Date of Birth certificate.*
- iii. *Permanent resident certificate*
- iv. *Health certificate from the concerned Chief Medical Officer of the District*
- v. *Discharge certificate from the Institution attending/last attended*
- vi. *Certificate from the concerned authority to the effect that no loan under-Self Employment Scheme has been taken by the concerned candidates.*
- vii. *Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.*

The appointment of the candidates as "Teacher" shall be subject to the following conditions:-

1. In case, at any stage, it emerges that the certificates/any relevant document furnished/produced by the appointee is/are fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate.
2. The salary of the appointee shall not be drawn and disbursed unless a satisfactory report of character and antecedents is received from Special Director General of Police (CID) to whom references have already been made by the Directorate vide various communications and also satisfactory report in respect of all the academic qualification certificates/testimonials are received in their favour.
3. The appointee shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.
4. In case of failure to join within stipulated time period of 21 days, the appointment shall be deemed to have been cancelled abinitio without any further notice in terms of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated 04.12.2019.
5. The appointment shall be subject to the final outcome of the cases/writ petition, if any, pending before any Hon'ble Court which may not be immediately within the knowledge of this directorate.


The DDO/CEO concerned shall implement the order only after obtaining the undertaking from the appointees to the effect that in case his/her character antecedents report is found unsatisfactory, he shall not claim for any salary and his appointment order shall be deemed to have been cancelled abinitio.

The inter-se seniority of the appointee in the particular grade/service shall be fixed in terms of Rule 24 of CCA Rules, 1956.
