- 1. In case, at any stage, it emerges that the certificates/any-relevant document furnished/ produced by the appointee is/are fake/fictitious, the appointment order shall be cancelled ab-initio and criminal proceedings shall be initiated against the candidate.
- 2. The appointee at the time of joining shall produce following testimonials in original to be verified by the concerned CEO/ DDO from respective issuing authorities.
 - i) Domicile Certificate issued by the competent authority.
 - ii) Matriculation/ Date of Birth Certificate.
 - iii) Academic/Professional Qualification Certificate(s).
 - iv) Health certificate from the concerned Chief Medical Office of the District.
 - v) Certificates from the District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under any self-employment scheme has been availed by the appointee.
 - vi) Valid relevant Category Certificate, if any applicable.
 - vii) Migrant Certificate from the Competent Authority.

- 3. The appointee shall furnish an undertaking in terms of SRO 412 of 2009, dated: 30-12-2009 issued by Revenue Department and also that the documents furnished by the candidate are genuine and shall be liable for termination of the service/ criminal proceedings, in case any of the document(s) at any time is/are fake, forged.
- 4. The salary of the appointee(s) shall not be drawn and disbursed to her unless authorization to this effect is sought from the CEO concerned after receipt of genuineness of all the documents (as indicated at 2).
- 5. The concerned CEO/DDO shall before releasing the salary verify the recognition of the Institute, equivalence/ validity of the degrees/course pursued by the candidate.
