**Sub: Acquiring of higher qualification by Mr. Nabaz Ahmad Sheikh RReT Teacher UPS Hafrada Kupwara and re-instatement of two suspended Senior Assistants thereof.**

Whereas, Mr. Farooq Ahmad Malik and Mr. Bashir Ahmad Malik, Senior Assistants of ZEO's office Villigam/Sogam were placed under suspension for drawing un-due salary in favour of Mr. Nabaz Ahmed Sheikh RReT Teacher in UPS Hafrada District Kupwara vide this office order No. 165-DSEK of 2022 dated 15/02/2022; and

Whereas, the issue was enquired by the committee comprising of 02 Officers viz. DEPO Kupwara and ZEO Handwara who furnished their report and observed as under:-

*"It has been observed that the I/C Accounts were not in know with regard to the absence of the concerned RReT and they have prepared the salary bills in his favour continuously. The Head of Institution being an newly engaged RRT is not well versed with regard to the rules/regulations and official procedure. The leave application marked by the concerned ZEO with his own hand has not been processed in the office of the ZEO Villigam, but has been kept in school records." The enquiry officers recommended that the suspendee senior Assistant may be re-instated with a warning to remain conscious in future and the HOI may also be warned to make every communication with the office of ZEO Villigam well in time; and*

Now, therefore, on the recommendations of the Enquiry Committee Mr. Farooq Ahmad Malik and Mr. Bashir Ahmad Malik, Senior Assistants of ZEO's office Villigam/Sogam are here-by re-instated with immediate effect with penalty of **Censure** in terms of rule 30 of Classification Control and Appeal Rules of 1956.
