Sub: Confirmation of In-charge Master as Master and cancellation of confirmation thereof.

ORDER NO. <u>319</u> – DSEK OF 2023 DATED 06 / 12/2023

Whereas, Mr. Ab. Rashid Hajam was placed as I/C Master under Social Caste category vide this office Order No. 831 DSEK of 2014 dated 24-06-2014; and

Whereas, the teacher is still working on the post of Incharge Master and drawing his salary on his own post viz. teacher in District Cadre Baramulla; and

Whereas, the CEO Baramulla enlisted the name of the official in the seniority of Teacher Cadre at S.No. 246 showing his date of appendiment as **08-01-2005** vide No. CEO/Bla/Estt/T/122494 dated 15-07-2023; and

Whereas, pursuant to the decision taken by the Divisional Departmental Promotion Committee in its meeting held on **20-07-2023**, the appointees of 08-01-2005 were considered for confirmation as Master in District Baramulla including the instant teacher; and

Whereas, considering his date of appointment as **08-01-2005**, the formal confirmation order, among others, of the teacher namely Mr. Ab. Rashid Hajam I/C Master was issued by this office vide Order No. 280 DSEK of 2023 dated 21-10-2023; and

Whereas, after issuance of the formal confirmation order, the CEO Baramulla vide his communication No. CEO/Bla/Estt/T-143027 dated 11-11-2023 communicated that the instant teacher is actually having date of appointment as **01-08-2005 instead of 08-01-2005**; and

Whereas, upon examination of the issue that the official having date of appointment as teacher **01-08-2005** were not otherwise eligible for such confirmation, as such the confirmation order issued in favour of the instant teacher need to be rescinded.

Now therefore, in view of the above, the confirmation order issued vide Order No. 280 DSEK of 2023 dated 21-10-2023 so far as it pertains to Mr. Ab Rashid Hajam I/C Master (appearing at **S.No. 09**) as Master in the Annexure to the above referred order is rescinded, ab-initio.
