Whereas, the Administrative Department vide letter No. Edu-I/227/2016 dated 30.06.2016 forwarded the list of 55 candidates selected as Teachers in District Cadre Srinagar, pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Secy/Sel/2016/12667-73, dated 11.05.2016 against SSB's notification No. 03 of 2014 under item No. 328;

Whereas, the selected candidates were informed through Print Media vide this office notification No. DSEK/Estt/III/B-Trs/592-94, dated: 07.09.2016 to deposit the undertakings on the devised format alongwith all original documents within Fifteen (15) days from the issuance of the said notification for issuance of their provisional appointment orders;

Whereas, Five candidates failed to submit the documents in this office and 01 candidate failed to join on the post as communicated by Chief Education Officer, Srinagar vide No. CEO/Estt/4767 dated 29.12.2016 and No. CEO/Estt/6341 dated 11.03.2017 resulting thereby Six posts remained unfilled of reserved categories (02/RBA, 01/ST and 03/SC);

Whereas, all the non-joining candidates were given final opportunity to join the department within 07 days from the publication of notification, vide this office notification No. DSEK/Estt/B-Trs/Sel/3062-63 dated 19.01.2017, but no selectee showed their interest to join the Department;

Whereas, the issue was the matter was taken up with the Administrative Department for conveying necessary instructions vide this office letter No. DSEK/Estt/III/5112 dated 23.02.2017;

Whereas, the Administrative Department vide letter No. Edu-I/227/2016 dated 22.03.2017, conveyed approval to the operation of wait list against the vacancies occurred due to non-joining/non-depositing of documents for the post of Teacher District Cadre Srinagar;

Whereas, wait list was operated in respect of only three candidates (RBA/02 & ST/01) due to the reason that selection of Two candidates under SC Category was kept withheld by the SSB for want of certain clarification and in respect of third slot there was no candidate available in the Waiting list under SC Category;

Whereas, the Administrative Department vide their communication No. Edu-I/227/2016 dated 24.10.2018, forwarded SSB's communication No. SSB/Secy/Sel/69/2016/9843-45 dated 07.09.2018, whereunder the selection of Shri Puneet Bhardwaj S/o Puran Chand figuring at S.No. 2/Wait under SC Category has been now released;

Whereas, upon examination of the issue, it revealed that the selection list was issued by the SSB in respect of 55 candidates belonging to reserved categories on 11.05.2016 and in light of SRO 60 dated 02.02.2018, the validity period of one year of those selectees whose recommendation/selection was kept withheld by the Recruiting Agency is to be reckoned from the date of release of their selection, as such the selection of the said candidate is still valid;

Now, therefore, in pursuance of the recommendations of the SSB/Administrative Department conveyed vide aforementioned communications, and in light of SRO 60 dated 02.02.2018, sanction is hereby accorded to the provisional appointment of Shri Puneet Bhardwaj S/o Puran Chand figuring at S.No. 2/Wait under SC Category as Teacher in District Cadre Srinagar in the pay scale of Rs.5200-20200 with grade pay of

Rs.2800 for Graduates (Pre-revised), admissible under SRO-93 dated 15.04.2009. The candidate shall report to Chief Education Officer Srinagar within 21 days from the date of issuance of this order for seeking further posting on his own risk and responsibility till the verification/authentication of all relevant documents/certificates is received from the concerned agencies.

The provisional appointment shall be subject to the following conditions:-

- The appointee/selectee shall be on probation for a period of two years.
- The appointee shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.
- In case, at any stage it emerges that the certificates/any relevant document furnished/produced by the selectee is fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate.
- The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.

The Chief Education Officer, Srinagar shall allow the candidate to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificate / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such order shall be drawn, in any case.
