Whereas, **Mtr. Maheen Shawl** was appointed in the Department as Teacher on 17/07/1999 and was subsequently posted at GMS Kaitech, District Budgam; and

Whereas, after joining on the post the teacher availed different kinds of leave from 01/03/2000 to 26/10/2000 even though the same was not otherwise at her credit and thereafter remained continuously/un-authorizedly absent from her legitimate duties w.e.f. 27/10/2000, as such served the Department for less than a year; and

Whereas, the teacher was provided enough opportunities by the DDO concerned to resume her duties which she failed indicating thereby that she is not interested to work any more in the Department; and

Whereas, un-authorized/continous absence from duties from last more than 20 years attracts action as warranted in terms of article 113 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-

Article 113

“After five years of continous absence on leave an officer is considered to be out of state employee.”

Whereas, the issue was placed before the Designated Committee in its meeting held on 16/04/2022 and after examining the case the committee took the following decision:

“Process for termination under Article-113 J&K CSR of 1956”.

Now, therefore, pursuant to the decision of the committee, **Mtr. Maheen Shawl, Teacher, GMS Kaitech, District Budgam** is hereby removed from the Government service in terms of **Article 113** of J&K Civil Services Rules (Volume I) of 1956 and **Rule 30(VII) of J&KCCA rules 1956**.

Whereas, the issue was placed before the Designated Committee in its meeting held on 16/04/2022 and after examining the case the committee decided that *“Process for termination under Article-113 J&K CSR, 1956”*.

Now, therefore, pursuant to the decision of the committee, Smt. 


