Whereas, the Administrative Department vide letter No. Edu-I/908/2017 dated 15.12.2017 forwarded the pending selection list of 68 candidates recommended for post of Teacher in District Cadre Anantnag in pursuance to Advertisement Notification No. 01 of 2012 dated 19.07.2012 (Item No. 001) under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/11258-65 dated: 06.11.2017, accordingly provisional appointment orders were issued in respect of all such candidates against whom recommendations were not kept withheld;

Whereas, 38 slots were accrued due to non-joining/cancellation of withheld recommendations, and accordingly waiting list was operated after obtaining authorization from the Administrative Department vide Government Order No. 205-Edu of 2020 dated 08.09.2020, leaving such candidates against whom recommendations were kept withheld by the JKSSB;

Whereas, among others recommendation in respect of Manisha Bhat W/o Vijay Kumar Bhat R/o Bonagund Verinag figuring at S.No. 30/Wait was also kept withheld by the JKSSB and has now been released vide JKSSB's letter No. SSB/Secy/Sel/39/2019/419-421 dated 18.01.2021 conveyed by Administrative Department vide letter No. Edu-I/908/2017 dated 15.04.2021;

Now, therefore, pursuant to recommendation of JKSSB as conveyed by the Administrative Department vide communication No. Edu-I/908/2017 dated 15.04.2021, sanction is hereby accorded to the provisional appointment of **Manisha Bhat W/o Vijay Kumar Bhat** whose particulars are reflected below as "Teacher" in District Cadre **Anantnag** (Advertisement Notice No. 01 of 2012 item No. 001) in terms of SRO-60 of 2018 dated 02.02.2018 in the **Pay Level 4 (Rs. 25500-81100)**, admissible under SRO-193 of 2018 dated 24.04.2018:

The appointee shall report to concerned Chief Education Officer within a period of 21 days from the date of issuance of this appointment order and shall be allowed to join only after production/submission of following documents/certificates in original to be verified subsequently:

- i. Academic Qualification Certificates
- ii. Date of Birth certificate.
- iii. Permanent resident certificate/Migration Certificate.
- iv. Health certificate from the concerned Chief Medical Officer of the District
- v. Discharge certificate from the Institution attending/ last attended
- vi. Certificate from the concerned authority to the effect that no loan under-Self Employment Scheme has been taken by the concerned candidates.
- vii. Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.

The appointment of the candidate as "Teacher" shall be subject to the following conditions:-

- (a) That he shall give an undertaking in the shape of an affidavit duly attested by the 1st Class Judicial Magistrate to the effect that:-
- In case, at any stage it emerges that the certificates/any relevant document furnished/produced by the appointee is/are fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate;
 - in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled ab-initio and he/she shall have no claim of his/her appointment.
 - The provisional appointees shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the District under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the action of his /her migration, in terms of the agreement to be executed by the appointee under SRO-412 before Chief Education Officer, Anantnag.
- (b) The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report in respect of (i) & (ii) above are received in her favour.
- (c) The appointee shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.
- (d) In case of failure to join within stipulated time period of 21 days, the appointment shall be deemed to have been cancelled abinitio without any further notice in terms of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated 04.12.2019.
- (e) The appointment shall be subject to the final outcome of the cases/writ petition, if any, pending before any Hon'ble Court which may not be immediately within the knowledge of this directorate.


The inter-se seniority of the appointee in the particular grade/service shall be fixed in terms of Rule 24 of CCA Rules, 1956.
