The appointment of the appointee shall further be subject to the following conditions:-

a) That he shall give an undertaking in the shape of an affidavit duly sworn in before Judicial Magistrate to the effect that:-

(i) If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Class-IV shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.

b) The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report in respect of (i) above is received in his favour.

c) The appointee shall be initially on probation for a period of two years.

d) The appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009 dated 24-12-2009.

c) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall cease his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
