Sanction is hereby accorded to the temporary appointment of Irshada Akhter D/o Gh Hassan Ganie W/o Farooq Ahmad Thoker deceased Teacher (Grade-II), Zone Verinag District Anantnag R/o Halsidar Tehsil Shahabad Bala District Anantnag Qualification : B.A. as Lab. Bearer (Multi Tasking Staff), in the Pay Level- SL1 (14800-47100) against an available post in HSS Mantipora District cadre Anantnag on compassionate grounds under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer Anantnag within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:-

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
5. All other relevant documents as are required under SRO-43/1994.

- The appointment of the candidate shall further be subject to the following conditions:
- i. that she shall give an undertaking in the shape of an affidavit to the effect that "If, on verification, genuineness of the qualification certificates and other certificates/documents from the concerned issuing authority is found fake/forged, the appointment made shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her."
 - ii. the salary of the appointee shall not be drawn and disbursed to her, unless a satisfactory report in respect of (i) above are received in her favour from the issuing authority.
 - iii. the appointee shall be initially on probation for a period of two years.
 - iv. the appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009 dated 24-12-2009.
 - v. if the appointee fails to join within a period of 21 days from the date of issuance of this order she shall cease her right of appointment which shall be deemed to have been cancelled ab-initio without any further notice.
