Sub: Resignation of Mr. Tawseef Ahmad Kumar, Ex-Class IV (MTS).

Ref: Chief Education Officer Pulwama's letter No. CEO/Pul/NT/22 /29/107 dated:10/01/2022 and No. CEO/Pul/NT/23/133/732 dated 04/03/2023.

Whereas, **Mr. Tawseef Ahmad Kumar** was appointed as Class-IV (MTS) vide Government order No. 1501-JK (Edu) of 2021 dated 23/10/2021 (figuring at S.No. 11) and was supposed to report the office of Chief Education Officer Pulwama within a period of 21 days from the date of issuance of said appointment order; and

Whereas, the appointee reported in the office of the CEO Pulwama on 09/11/2021 and subsequently was adjusted in BHS Chandhara, Pampore by the CEO Pulwama vide order No. 100-of CEO Pul 2021 dated 18/11/2021; and

Whereas, the appointee joined at BHS Chandhara on **22/11/2021** and on the same day i.e **22/11/2021**, tendered his resignation on domestic grounds from the post as per the Affidavit executed before the Hon'ble Court of Munsif Judicial Magistrate 1st Class Pulwama; and

Whereas, Chief Education Officer Pulwama vide letter No. CEO/Pul/NT/22/29/107 dated 10/01/2022 submitted the case of the official for acceptance of resignation with effect from **22/11/2021**; and

Whereas, in the meantime the applicant approached this Directorate with a representation requesting therein for withdrawal of his resignation on the plea that he had tendered his resignation in haste and in the state of mental anxiety; and

Whereas, this Directorate vide letter No. DSEK/NT/Resign/7-12/93-2021/All/678 dated 15/03/2022 directed to CEO Pulwama to withdraw applicant's resignation under rules; and

Whereas, CEO Pulwama vide letter No. CEO/Pul/NT/22/223/ 1028 dated 18/04/2022 informed that as reported by the Headmaster BHS Chandhara, Pampore, Mr. Tawseef Ahmad Kumar, Class-IV (MTS) failed to rejoin his duties; and

Whereas, the said candidate approached to this Directorate on 04/06/2022 via medium of a representation with the request for an another mercy chance to rejoin his duties in the department; and

Whereas, this Directorate vide letter No. DSEK/NT/Resign/7-12/2021/93/All/3321-22 dated 23/07/2022 followed by the reminder dated 11/10/2022 instructed the District Vigilance Officer (DVO) Pulwama to enquire the matter with regard to resignation in favour of the Mr. Tawseef Ahmad Kumar, Class-IV (MTS); and

Whereas, Chief Education officer, Pulwama vide his communication No. CEO/PUL/NT/22/471/2638 Dated: 13/10/2022 communicated that the post of DVO is lying vacant in the District as the earlier DVO was elevated to the rank of Principal DIET; and

Whereas, Chief Education Officer, Pulwama was requested by this office communication dated: 15/11/2022 to investigate the matter and furnish the comprehensive report with documentary evidence along with Show Cause Notice (if any) served to this office within 10 days; and

Whereas, the District Education Planning Officer (DEPO), Pulwama vide letter No. CEO/Pul/NT/22/589/3192 dated 13/12/2022 submitted inquiry report stating therein that the applicant was very much aware about the communications regarding acceptance of withdrawal of his resignation; and

Whereas, vide this office letter No. DSEK/NT/Resign/712/93-2021/All/520 dated 16/02/2023, the CEO Pulwama was again asked to furnish the specific recommendation/comments on the matter and also inform this Directorate whether any Show Cause Notice has been served to Mr. Tawseef Ahmad Kumar or otherwise; and

Whereas, Chief Education Officer Pulwama vide letter No CEO/ Pul/NT/23/133/732 dated 04/03/2023 enclosed a report of Headmaster, BHS Chandhara, Pampore stating therein as the incumbent never attended the school even the applicant has submitted his resignation on the very same day of joining viz **22/11/2021** supported with an Affidavit duly executed before the Munsiff Judicial Magistrate, 1st Class Pulwama stating therein **"that the applicant has some domestic problems and not able to perform his job/duties so he intends to resign from the said post and will not claim for the said post again in future"** as such there was no reason to serve Show Cause Notice in respect of Mr. Tawseef Ahmad Kumar; and

Whereas, the issue was placed before the Designated Committee in its meeting held on 07/10/2023, and a committee after thread-bare discussion took the following decision:

"To accept the resignation of the candidate and post is deemed to have been vacated w.e.f 22/11/2021"

Now therefore, pursuant to the decision of the Designated Committee and as per recommendations of Chief Education Officer, Pulwama, the resignation of Mr. Tawseef Ahmad Kumar (Class-IV MTS) is accepted **in terms of Article-200 of J&K CSR Vol-I** and the post is deemed to be lien free w.e.f **22/11/2021**.
