Pending vigilance clearance and subject to the ratification by Departmental Promotion Committee, sanction is hereby accorded to the placement of following 04 (four) Library Assistants of District Baramulla, Budgam, Kupwara and Pulwama whose details are given against their name as I/c Junior Librarians in their own pay and grade, for a period of six months or till the post is filled up on regular basis by the DPC, whichever is earlier.

The placement of Library Assistants as I/c Junior Librarians is subject to fulfilment of following explicit conditions:-

1. If the Library Assistant as named above in this order is on subsequent verification, found not eligible for such placement, this order will not confer any right on him/her and his/her placement on the higher post (made hereby) shall be rescinded in that case. It will be personal responsibility of the Chief Education officer/Drawing and Disbursing Officer concerned to verify particulars of the official with reference to his/her original service record and ensure that the date of 1st appointment as Class-IV as well as other particulars recorded against him/her (therein this order) are correct. Variation if any found should be brought to the notice of this Directorate for further orders. In that case the Library Assistant shall not be relieved for his/her placement on the higher post.
2. The Chief Education Officer concerned shall verify the Library Science degree/diploma certificates of the incumbents and shall allow them to join only when/if the degree/diploma certificates are found genuine.
3. The elevated official must necessarily be holding substantive genuine appointment and un-interrupted service. The benefit of placement shall not be allowed in case the official is under suspension or in the case the departmental proceedings may be pending against him/her or his/her work and conduct may not be satisfactory.
4. Any incumbent(s)/official(s) aggrieved of this order shall approach this Directorate through respective Chief Education Officers within 21 days from the date of issuance of this order, alongwith necessary documentary evidence in support of his/her claim.
5. The placement shall be without prejudice to the outcome of the case, if any sub-judice/impugned or pending before the Hon'ble High Court or any other court and other orders, if any passed by the competent authority, which may not be immediately within the knowledge of this Directorate.
6. The Chief Education officer concerned must ensure that there is nothing adverse against the official from VOK/Crime/Police/CID.
7. The I/c Junior Librarian(s) shall report to the concerned Chief Education Officer within 21 days from the date of issuance of this order. If any such I/c Junior Librarian(s) fail to join within the stipulated period of time, it shall be presumed that he/she has foregone his/her placement and his/her placement as I/c Junior Librarian shall deemed to have been withdrawn without any further notice.
