Whereas, Principal Govt. College of Education (IASE), Srinagar vide No. GCOE/IASE/23/3414 dated: 28/12/2023 requested to depute **100** un-trained graduate/post-graduate Teachers for undergoing B.Ed (regular) course at the said Institute for the session **2024-26**; and

Whereas, all the Chief Education Officers vide this office letter No. DSEK/EStt-III/B-Trs/A/0071 dated: 24/01/2024 were requested to furnish desirous/Senior most un-trained graduate/post graduate teachers for undergoing the said course; and

Whereas, on the basis of details furnished by the respective Chief Education Officers, this office prepared the list of **100 (One Hundred)** In-Service un-trained graduate/post-graduate Teachers along with the Wait list of **20 candidates** forming Annexure "A" and "B" of this order respectively, strictly in proportion to the No. of un-trained graduate/post-graduate Teachers and seniority of such teachers in their respective districts; and

Now therefore sanction is hereby accorded to the deputation of **100 (One Hundred)** In-Service un-trained graduate/post-graduate Teachers forming **Annexure "A" of this Order** for undergoing Bed (regular course) at the Govt. College of Education, IASE Srinagar for the session **2024-26** on the following terms and conditions:-

a. The Chief Education Officer concerned shall verify the particulars of each of the official(s) with reference to his/ her Original service records / appointment Order/ regularization Order and ensure that the details recorded against each official (herewith in the Annexure of this Order) are correct. Variations, if any found, should be immediately brought into the notice of this Directorate for further orders and in that case, no such official shall be relieved until further clarification/instructions in the case is sought from this Directorate.

b. The Chief Education Officers before implementing the Order, shall satisfy themselves about the genuineness of qualification/degree certificates and ensure that the official(s)has/have qualified if any course/degree during in-service has/have obtained prior permission from the competent authority viz. Administrative Department.

c. That the official must necessarily be holding genuine appointment on substantive basis, in the department and has been appointed/ engaged by the Competent Authority, has uninterrupted service, and

shall not fall in the category of Fake, Fraud, Ado/Contractual appointment/Migrant substitute and there is nothing adverse against the official(s) from VOK/Crime/ Police or any other agency.

d. That the deputation is made without prejudice to due consideration of

superior claim, if any reported.

e. That the deputee (un-trained in-service graduate/post-graduate teacher) has not been nominated for undergoing such training earlier.

- f. That a deputee who may be working against long or short leave arrangement or against a lien post of migrant teacher shall not be relieved for the course.
- g. That the deputee Teachers shall require to join the B.Ed course at the College of Education, Srinagar within 07 days from the date of issuance of this order. Any deputee who fails to report to the principal, College of Education, Srinagar with in specified date, shall forfeit his/her claim for such deputation and the deputation in his/her favour shall be liable to be cancelled besides the same shall invariably be recorded in his/her service records and his/her application for such deputation in future shall not be entertained.

h. That the Chief Education Officers shall put in place an appropriate mechanism to make up for the gaps resulting in various schools as a result of this deputation Order.

Before implementing the order, it shall be the responsibility of Chief Education Officer and DDO (concern) to ensure fulfillment of all formalities/conditions as laid down herein above. In case, any deputee is found registered for B.Ed through IGNOU/NIOS (Distance Mode), such deputee shall not be relieved for B.Ed deputation until further orders from this Directorate.
