Whereas, Chief Education Officer, Baramulla vide letter No. CEO/Bla/Estt/29147 dated 29.12.2016 forwarded verification reports of all the testimonials/documents of the said appointee for declaring her provisional appointment as absolute, after a gap of about 4 years;

Whereas, vide this office communication No. Estt-III/B-Trs/SSB/Tr/Bla/016/5123 dated 27.02.2017, followed by communication No. Estt/III/B-Trs/7174 dated 26.10.2017, Chief Education Officer Baramulla was asked to enquire into the matter and furnish the reasons for belated submission of the case:

Whereas, Chief Education Officer Baramulla vide communication No. CEO/Bla/SSA/29833-34 dated 21.08.2018 furnished the report of enquirey committee which recommended the case for issuance of confirmation to the provisional appointment;

Whereas, vide this office Order No. 1151-DSEK of 2018 dated 06.09.2018, the matter was again enquired by Joint Director (North) and Chief Accounts Officer, DSEK for establishing the factual report with regard to late submission of the case and drawal of salary in absence of formal appointment order;

Whereas, the Enquiry Committee furnished its report vide communication No. JDE/NK/428 dated 10.10.2018 and recommended the case for issuance of confirmation to the provisional appointment:

Whereas, in pursuance to this office communication dated 31.12.2018, Chief Education Officer, Baramulla got the matter published in local dailies for obtaining objections from the general public (if any) before declaring her provisional appointment absolute;

Whereas, the notice was published in local dailies for obtaining objections, however, no objection was received in the stipulated time period as intimated by Chief Education Officer Baramulla vide communication No. CEO/Bla/SMS/45314-15 dated 29.01.2019;

Now, therefore, in view of the recommendations of Enquiry Committees and Chief Education Officer Baramulla on the subject and on the basis of verification report of certificates/testimonials, sanction is hereby accorded to the confirmation of the provisional appointment in respect of SUFEENA BANO who stand provisionally appointed as Teacher in District Cadre Baramulla vide Order No. 1812-DSEK of 2012 Dated 24.09.2012.
