The appointees shall report to the concerned Chief Education Officers within a period of 21 days from the date of issuance of this appointment order for seeking further posting orders on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities. In case of failure to join within stipulated time period, the appointment shall be deemed to have been cancelled ab-initio without any further notice, in light of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated: 04/12/2019.

The provisional appointment shall be subject to the following conditions:-

A) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference

shall be made by the concerned Chief Education Officer; his/her appointment shall itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.

The Chief Education Officer, Budgam shall allow the candidate to join on the post after verifying the following certificates (in original).

• total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the District under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the acton of his /her migration, in terms of the agreement to be executed by the appointee under SRO-412 before Chief Education Officer, Budgam.

The provisional appointment of candidate is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court which are not immediately within the knowledge of this Directorate.
