Whereas the Divisional Commissioner Kashmir vide communication No: Divcom/ps/misc/2021/2640-41 dated: 12/10/2021 has desired to effect the transfer of PM Package employees to the schools falling within Municipal areas; and

Whereas the Divisional Commissioner Kashmir vide letter No: Divcom/ps/2021/4143 dated: 31/03/2022 has sought action taken report in the matter; and

Whereas the Divisional Commissioner Kashmir directed in the meetings held on 05/04/2022, 07/05/2022 and 18/05/2022, to effect the transfers as per the requests received from PM Package employees.

Now therefore in view of the above and in pursuance to the directions given by the Divisional Commissioner Kashmir, the transfer of PM Package employees is hereby ordered as per annexure forming to this order, with immediate effect.

Before making the orders operational, it is the entire responsibility of CEO/DDO concerned to ensure the fulfillment of following explicit conditions:-

- 1.the incumbents are holding genuine appointment ✓ and substantive status in the department.
2. the incumbents have been initially appointed as teachers and not RRT/RET teachers.
- 3.there is no case pending disposal against the transferee before the department or any other investigating agency.
