The condition of probation, pay and allowances and fixation of initial tenure of the appointee shall be governed by Jammu & Kashmir Probationer (Conditions of Service, Pay & Allowances) and Fixation of Tenure Rules, 2020 issued vide S.O. 192 of 2020 dated 17.06.2020 read with Government Order No. 654-JK(GAD) of 2020 dated 19.06.2020.
 - II. The appointees shall be governed under New Pension Scheme as per SRO 400 of 2009 dated 24.12.2009.
 - III. In case, at any stage it emerges that the certificates/any relevant document furnished/produced by the selectee is/are fake/fictitious, the appointment order shall be cancelled ab-initio and criminal proceedings shall be initiated against the candidate and to this effect the provisional appointee shall give an undertaking by way of affidavit duly attested by the 1st Class Judicial Magistrate;
 - IV. The appointees shall give an undertaking by way of affidavit duly attested by the 1st Class Judicial Magistrate to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.
 - V. The appointees shall give an undertaking in shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled ab-initio and he/she shall have no claim of his/her appointment;
 - VI. The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.

The appointees shall report to the concerned Chief Education Officers within a period of 21 days from the date of issuance of this appointment order for seeking further posting orders on his own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities. In case of failure to join within stipulated time period, the appointment shall be deemed to have been cancelled ab-initio without any further notice, in light of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated: 04/12/2019.
