Sub: Un-authorized absence case of Smt. Ranjit Kour, Master, HS Sangri Top, Baramulla and removal of service thereof.

Whereas, Smt. Ranjit Kour, Master, HS Sangri-Top, Baramulla remained absent from her legitimate duties w.e.f. 01/05/2017 un-authorizedly; and

Whereas, the said official was provided enough opportunities by the DDO concerned and by this office on 20/04/2021 to resume her duties and furnish her statement of defence for remaining away from her duties, which she responded to; and

Whereas, after examining the reply of the said master, the case was placed before the designated committee's meeting held on 07/06/2021 and after thread bare discussion, the committee decided to "allow the master to join on the post treating the period of absence as dies-non w.e.f 01/05/2017 to 23/12/2020 and from 24/12/2020 to till date as leave whatever kind due subject to production of certain documents/certificates"; and

Whereas, the decision of the designated committee was conveyed to CEO Baramulla vide this office communication dated: 30/07/2021 for further necessary action; and

Whereas, the CEO Baramulla vide his letter dated: 17/01/2022 reported that instead of joining on the post pursuant to the decision of the designated committee the master applied for voluntary retirement which is stated that he is not in a position to process the case as the official has not attended the office physically nor provided requisite documents/certficates; and

Whereas, the issue was again placed before the Designated Committee in light of the report submitted by the CEO Baramulla in its meeting held on 16/04/2022 and after examining the case the committee decided that "Process for termination under Article-128 J&K CSR, 1956".

Whereas, the master remained absent from her legitimate duties w.e.f 01/05/2017 un-authorizedly which attracts action as warranted in terms of Article 128 & Article 113 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-

Article 128

'Absence without leave or after the end of leave involves loss of appointment'.

Article 113

"After five years of continous absence on leave an officer is considered to be out of state employee."

Now, therefore, pursuant to the decision of the committee, Smt. Ranjit Kour, Master, HS Sangri Top, Baramulla who is absent from her legitimate duties w.e.f 01/05/2017 un-authorizedly, is hereby removed from the Government service in terms of Article 128 & Artice 113 of J&K Civil Services Rules (Volume I) of 1956 and Rule 30(VII) of J&KCCA rules 1956.
