Pursuant to the selection made by the J&K Service Selection Board, Jammu and release of recommendation conveyed by the Administrative Department vide above referred communication, sanction is hereby accorded to the provisional appointment of **Mr. Reghu Sandhu S/o Sadiq Sandhu R/o RS. Pura Jammu** (whose particulars are reflected below) as "**Junior Assistant**" in District cadre **Kulgam** under **SC** category in pursuance to SSB's advertisement Notice No. 02 of 2017 dated 18/10/2017 in minimum of **Pay Level 4 (25500-81100/-)**. The condition of probation, pay and allowances and fixation of initial tenure of the appointee shall be governed by **Jammu & Kashmir Probationer (Condition of Service, Pay & Allowances) and Fixation of Tenure Rules 2020** issued vide **S.O 192 & S.O 194 of 2020** dated 17/06/2020. The appointment of the candidate shall be subject to outcome of any writ petition(s), if any, pending in any Court of competent jurisdiction or any order which may not be presently within the knowledge of this Directorate.

The appointment of the candidate as "**Junior Assistant**" is subject to the following conditions:-

- I. The appointee shall be governed under New Pension Scheme as Per SRO 400 of 2009 dated 24/12/2009.
- II. In case, at any stage it emerges that the certificates/any relevant document furnished /produced by the selectee is/are/ fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate and to this effect the provisional appointee shall give an undertaking by way of affidavit duly attested by the 1st Class Judicial Magistrate;
- III. The appointee shall give an undertaking by way of Affidavit duly attested by the 1st Class Judicial Magistrate to the effect that they will not apply for transfer in any case where/he/she have been adjusted/posted.
- IV. The appointee shall give an undertaking in shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer, his/her appointment shall be itself stand cancelled ab-initio and he/she shall have no claim of his/her appointment.

The appointee shall report to the **Chief Education Officer, Kulgam** within a period of **21 days** from the date of issuance of this appointment order for seeking further posting orders. In case of failure to join within stipulated time period, the appointment shall be deemed to have been cancelled abinitio without further notice in terms of the circular instructions issued by GAD vide No. 08-JK (GAD) of 2019 dated 04/12/2019;

The Chief Education Officer, Kulgam shall allow the candidate to join on the post after observing all the conditions of appointment order and after verifying the following certificates (in original)

- Character & antecedents certificate from Additional Director General of Police (CID).
- All Academic/Technical Qualification certificates.
- Permanent Resident Certificate.
- Category Certificate.
- Disability certificate.
- Age and health certificate.
- Discharge certificate from the Institution attending / last attended.
- Certificate from District Industries Centre/Employment Exchange to the effect that no loan under self-employment scheme has been taken.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority in order to ensure that the qualifications as reflected in the selection list is according to the genuineness marks card/qualification certificate.


The Provisional appointment order of the candidate shall be confirmed only after receiving verification reports viz date of birth certificates/qualification/marks certificates/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary shall be drawn till issuance of confirmation order;

The inter-se seniority to the appointee in the particular grade/service shall be fixed giving due consideration to their inter-se merit in the selection in terms of Rule 24 CCA Rules, 1956.
