ORDER NO: - 349 - DSEK OF 2020 DATED : - 29 - 09 - 2020

Whereas, in pursuance to JKSSB's advertisement notification No. 01 of 2012 dated 19.07.2012, as many as 623 candidates were selected for the post of Teacher in various District Cadres of Kashmir Division under Prime Minister's Special Package for Kashmiri Migrants, and conveyed to this office by the Administrative Department in different communications for issuance of appointment orders in their favour after fulfilling all formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009;

Whereas, this office issued provisional appointment orders in respect of all such candidates whose recommendations were either already cleared or released from time to time on standard terms and conditions as laid down in SRO-412 of 2009;

Whereas, the Administrative Department vide Government Order No. 205-Edu of 2020 dated 08.09.2020, extended the validity of waiting list adjunct to the select list for the post of Teacher (PM Package) beyond the date of its expiry upto 30.09.2020, and this Directorate has been instructed to issue formal appointment orders in favour of the candidates falling in the waiting list against all the available vacancies of Teacher (PM Package) in pursuance to Advertisement Notification No. 01 of 2012 dated 19.07.2012;

Whereas, vide this office communication No. DSEK/Estt/9697-I dated 14.09.2020, all the Chief Education Officers of Kashmir Division were requested to furnish the list of all non-joining candidates who were appointed as Teachers under PM's Package under various orders in pursuance to SSB's advertisement notification No. 01 of 2012;

Whereas, in response to the communication dated 14.09.2020, the Chief Education Officer Shopian/Srinagar/Budgam/Anantnag communicated the particulars Thirteen (13) candidates who failed to join the Department within the stipulated time period, as such the provisional appointment order in respect of these non-joining candidates need to be cancelled and subsequently fill these posts by utilization of waiting list in light of the instructions of the Administrative Department conveyed vide order dated 08.09.2020.

Now, therefore, sanction is hereby accorded to the:-

- i) Cancellation of provisional appointment order in respect of Thirteen (13) candidates (01/Shopian, 08/Srinagar, 03/Budgam & 01/Anantnag) whose full particulars are reflected as Annexure "A" to this order *ab-initio*;
- Provisional appointment of Twelve candidates as Teacher in District Cadre Shopian (01), Srinagar (08) and Budgam (03), against the consequential non-joining accrued slots under Prime Minister's Special Package for Rehabilitation of Kashmiri Migrants in the Pay scale of Rs.5200-20200 (Pre-revised) with grade pay of Rs.2800 for Graduates and above and Rs. 2400 for Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009 as per the Annexure "B" to this order.

These provisional appointees are required to report to concerned Chief Education Officers, within a period of 21 days from the date of issuance of this appointment order for seeking further posting orders. In case of failure to join within stipulated time period, the appointment shall be deemed to have been cancelled abinitio without any further notice in terms of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated 04.12.2019

The provisional appointment shall be subject to the following conditions:-

- A) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to who a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.
- B) The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned issuing authority.

The Chief Education Officer, concerned shall allow the candidate to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the acton of his /her migration, in terms of the agreement to be executed by each appointee before concerned Chief Education Officers under SRO-412;

The provisional appointment order of the candidate shall be confirmed only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary shall be drawn till issuance of confirmation order.

The inter-se seniority of the appointee in the particular grade/service shall be fixed giving due consideration to their inter-se merit in the selection in terms of Rule 24 of CCA Rules, 1956. Sd/-
