Sub: Un-authorized absence case of Smt. Arumella Koul, Teacher BHS Diver, Baramulla and removal of service thereof.

Order No: 35 DSEK of 2021

Dated: 12 / 10 / 2021

Whereas, Smt. Arumella Koul remained un-authorizedly absent from her legitimate duties w.e.f. 11/03/2013 and the teacher was provided opportunities by the DDO concerned to resume her duties which she failed to avail; and

Whereas, the issue was placed before the Designated Committee in its meeting held on 29/12/2020 and after examining the case the committee took the following decision:

"Process for termination be initiated against the teacher"

Whereas, the teacher was again provided an opportunity to be heard by this office on 26/04/2021 wherein the decision of the committee was also conveyed to the said teacher but the teacher didn't respond. Besides, on 06/07/2021 a joint show cause notice was also served to the teacher directing therein to present herself before this Directorate along with statement of defense within 07 days from the date of issuance of notice ; and

Whereas, neither the teacher presented herself before this Directorate nor responded to these repeated notices, indicating thereby that she is not interested to work in this Department; and

Whereas, remaining un-authorizedly/continuously absent from duties attracts action as warranted in terms of article 113 & Article 128 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-

Article 113

"After five years of continuous absence on leave an officer is considered to be out of state employee."

Article 128

'Absence without leave or after the end of leave involves loss of appointment'

Now, therefore, pursuant to the decision of the committee, Smt. Arumella Koul, Teacher BHS Diver, Baramulla is hereby removed from Government service in terms of Article 113 and Article 128 of J&K Civil Services Rules (Volume I) of 1956 and rule 30(vii) of J&KCCA rules 1956.

Whereas, Smt. Ranjeet Kour, Teacher HS Kralweth, Baramulla applied for 06 months extra ordinary w.e.f. 28/04/2014 with station permission to proceed United States of America (outside the country); and

Whereas, in-anticipation of station leave permission/sanction of leave from the competent authority the teacher proceeded outside the country United States of America and as such remained un-authorizedly absent from her legitimate duties w.e.f. 28/04/2014, and

Whereas, the teacher was provided opportunities by the DDO concerned to resume her duties which she failed; and

Whereas, the issue was brought into the notice of this Directorate by CEO Baramulla on 19/10/2020 and accordingly the teacher was served a notice by this office on 18/05/2021 followed by a joint show cause notice on 06/07/2021, wherein she was provided opportunity to present herself before this Directorate along with statement of defense within 07 days from the date of issuance of notice;

Whereas, neither the teacher presented herself before this Directorate nor responded to these repeated notices, indicating thereby that she is not interested to work in this Department; and

Whereas, in terms of circular instructions issued by the Finance Department under No. A/46(2017)-I-862 dated: 21/02/2019, "*When a State Govt. employee who intends to visit foreign country on private affairs during the period of leave prior permission of the competent authority to leave the station is required*"; and

Whereas, the issue was placed before the Designated Committee and after examining the case the committee took the following decision:

"Process for termination be initiated against the teacher under Article-128 J&K CSR"

Whereas, remaining un-authorizedly/continuously absent from duties attracts action as warranted in terms of article 113 & Article 128 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-

Article 113

"After five years of continuous absence on leave an officer is considered to be out of state employee."

Article 128

'Absence without leave or after the end of leave involves loss of appointment'.

Now, therefore, pursuant to the decision of the committee, Smt. Ranjeet Kour, Teacher HS Kralweth, Baramulla is hereby removed from Government service in terms of Article 128 & Article 113 of J&K Civil Services Rules (Volume I) of 1956 and rule 30(vii) of J&KCCA rules 1956.

Whereas, Mr. Sunil Kumar Raina was appointed in the Department on 28/07/2017 as Teacher under PM's package and subsequently posted in MS Moti Mohalla, Zone Nishat District Srinagar; and

Whereas, the said teacher continued on the post just for 03 months upto 31/10/2017 and thereafter remained un-authorizedly absent from duties w.e.f. 01/11/2017, without completion of probation period; and

Whereas, the teacher was provided enough opportunities to resume his duties by the Drawing & Disbursing officer concerned on 16/11/2017 followed by another notices dated: 20/01/2018-& 13/03/2018 to resume his legitimate duties but failed to do so and continued to remain absent from his legitimate duties; and

Whereas, the teacher was again provided an opportunity on 09/04/2021 & 06/07/2021 (through a Joint Show cause notice) asking there in to present himself before this Directorate alongwith statement of defense within a period of 10 days but the teacher didn't responded to these notices; and

Whereas, un-authorized absence from duties attracts action as warranted in terms of Article 128 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-

Article 128

'Absence without leave or after the end of leave involves loss of appointment'

Whereas, the issue was placed before the Designated Committee in its meeting held on 27/10/2021 and after examining the case the committee took the following decision:

"to process for termination of services under Article 128 of CSR Vol-I".

Now, therefore, pursuant to the decision of the committee Mr. Sunil Kumar Raina, Teacher, MS Moti Mohalla, District Srinagar is hereby removed from Government service in terms of Article 128 of J&K Civil Services Rules (Volume I) of 1956 read with rule 30(vii) of J&KCCA Rules 1956.
