Whereas, the Administrative Department (Education) vide letter No. Edu-I/367/2018, dated. 25/04/2018, has forwarded select list of **10 (ten)** candidates as Lab. Assistants, under open merit category of **District cadre Srinagar**, issued by the Secretary J&K Service Selection Board Jammu's vide No. SSB/Secy/Sel/2018/1842-48, dated 19/02/2018, under Hon'ble Prime Minister's Special Package for Kashmiri Migrants for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu & Kashmir Migrants (Special Drive Recruitment Rules, 2009, issued under SRO. 412 of 2009, dated 31/12/2009.

Whereas, recommendation in respect of **02 (two)** candidates, has been kept withheld by J&K Service Selection Board, for want of certain clarification, leaving **08 (eight)**, candidates for considering their candidature for issuance of appointment orders;

Whereas, this office vide Notification No. DESK/NT/Mig-Return/26-31/SF/752-53, dated. 05/06/2018 appeared in Press through information department, dated, 07/06/2018 directing the selectees to deposit their requisite original as well as self attested certificates/testimonials and undertakings alongwith agreement on the devised format duly attested by Ist Class Magistrate in terms of SRO-412 of 2009, dated.31/12/2009, in this Directorate **within (15) days** from the date of publishing of the notification in press;

Whereas, in response to the said notification none of the selectee has deposited his documents/testimonials in this Directorate, despite final Notice has been served to them vide this office notification No.DSEK/NT/Mig-Return/26-31/SF-II/926-27, dated. 04/07/2018; published in Kashmir Images on 05/07/2018;

Whereas, the Directorate took up the matter with the Admn. Deptt. vide this office letter No. DESK/NT/Mig-Return/26-31/SF/1013, dated. 27/07/2018 for authorisation of operating the wait list and in return the Admn. Deptt. vide letter No. Edu-I/367/2018, dated. 31/12/2018, has instructed to issue formal appointment orders in favour of all selected candidates, directing them to join within a prescribed period of 21 days and the appointment orders of all such candidates who fail to join on their appointments within the prescribed period should be accordingly cancelled before seeking authorization with regard to operationalization of waitlist from the Administrative Department;

Now, therefore, sanction is hereby accorded to the provisional appointment of following **eight (08)** selected candidates, as Laboratory Assistant in **District Cadre Srinagar**, against the posts created under Hon'ble Prime Minister's Special Package for Kashmiri Migrants, in the pay band of Rs.5200-20200+ grade of Rs.1900/. The full particulars/merit position assigned to them by J&K Service Selection Board are indicated against each.

The candidates are required to report to the Chief Education Office, **Srinagar**, within (21) days from the date of issuance of this Order, for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/Certificates are received from the concerned agencies. In case of failure to join within the stipulated period, the appointment shall liable to be cancelled;

The appointee shall be governed under New pension Scheme as notified vide **SRO-400 of 2009 dated 24.12.2009**.

The appointees shall be on probation for a period of **two years** and subject to production of following certificates (in original) before the Chief Education Officer, **concerned** who shall be required to get these certificates verified/authenticated from the concerned issuing authorities

- i. Character and antecedents certificate from Additional Director General of Police (CID).
- ii. Academic / Qualification certificates viz Degree Marks.
- iii. Permanent resident certificate
- iv. Age and health certificate
- v. Discharge certificate from the Institution attending/last attended
- vi. Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee.
- vii. Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- viii. Migrant Certificate from competent authority, whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- ix. Agreement in-terms of SRO-412 of 2009, dated. 31/12/2009 and undertaking (duly attested) by Judicial Magistrate (1st Class) forming Annexure "A" & "B" to this order.
- x. Total Marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

The salary of the appointees shall not be drawn and disbursed unless;

- Satisfactory report about his/her character and antecedents is received from **Inspector General of Police (CID) J&K** and genuineness/verification report for qualification/Technical Certificate/ Marks Certificates and category certificates (if any) from the issuing authority.
- Appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his/her character and antecedents is received from the concerned **Inspector General of Police (CID) J&K**, the appointee shall have no right to claim his/her appointment as Lab. Assistant and appointment as such shall be deemed to have been cancelled ab-initio.
- If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled/abinitio.
- Appointee shall give an undertaking duly attested by Judicial Magistrate 1st Class to the effect that he/she will not apply for transfer from concerned District in any case.

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case any appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the action of his/her migration, in terms of the agreement executed by each appointee under SRO-412 of 2009.

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through **concerned** Chief Education Officer duly counter-signed, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidate till formal appointment order is issued from this Directorate.

The inter-seniority of the appointee shall be in the order in which his/her name appear in the select list furnished by the J&K Services Selection Board.

This order is issued without prejudice to writ petition(s)/suit, if any, pending/sub-judice before the Hon'ble High Court or any other Court of law or any order which may not be presently within the knowledge of this Directorate.

WHEREAS the Government has decided to provide employment to unemployed Kashmir migrant youth in terms of Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rules, 2009;

WHEREAS vide Order No. _____ dated _____ The executor has been appointed on probation as _____ in the Department _____ subject to execution of this Agreement; and inter-alia, on the explicit condition that his appointment as such shall subsist only so long as he serves in the Kashmir Valley; and

WHEREAS that the appointee shall be considered for regularization on the basis of his performance and satisfactory completion of period of probation in accordance with aforementioned rules, and

WHEREAS that the appointee agrees to serve in Kashmir Valley and will at no stage opt or seek for transfer outside Kashmir Valley; and

WHEREAS the appointee agrees that in case he migrates again from Kashmir Valley at any stage for any reasons whatsoever, he will stand automatically terminated from the service and shall have no claim against any post under the state; and

WHEREAS if the appointee will fully neglects or refuses to perform his duty in Kashmir Valley the appointing authority shall immediately terminate his service and

WHEREAS the appointee will at no stage seek or opt for transfer outside the Kashmir Valley.
Now, therefore, I accept the said terms and conditions of appointment.
