Whereas, the Administrative Department vide letter No. Edu-I/908/2017 dated 15.12.2017 forwarded the pending selection list of candidates selected as Teachers in various District Cadres including Srinagar in pursuance to J&K Services Selection Board, Srinagar's Advertisement Notification No. 01 of 2012 dated 19.07.2012 (Item No. 009) under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all formalities and conditions as envisaged under Jammu and Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009;

Whereas, among others, selection in respect of Smt. Deepshikha Raina D/o Gowri Shankar Raina figuring at S.No. 190 in District Cadre Srinagar was earlier kept withheld by SSB and has now been released vide SSB's Order No. 285-SSB of 2018 dated 23.05.2018, however, has been displaced from S.No.190 to 14/wait due to the fact that her Gradation Degree has not been considered by SSB to which she has furnished an undertaking to the effect that her qualfication be treated as 10+2 only as she failed to produce bonafide certifiate of Graduation Degree resulting with 02 points were deducted from her overall merit with revised merit position as 40.000.

Whereas, vide this office notification No. DSEK/Estt/III/B-Trs/PMP/017/3999-02 dated 24.01.2019, the above named selectee was asked to deposit his undertakings and agreement on the devised format duly attested by the 1st Class Magistrate in terms of SRO-412 of 2009 dated 31.12.2009 alongwith all original certificates/testimonials with a set of self attested Xerox copies within Ten (10) days from the date of publication of the notification;

Whereas, in response to the above notification dated 24.01.2019 the said candidates deposited the requisite papers in this Directorate, for issuance of provisional appointment order in her favour;

Now, therefore, sanction is hereby accorded to the provisional appointment of Smt. Deepshikha Raina D/o Gowri Shankar Raina (whose full details are given below) as Teacher in District Cadre Srinagar against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants in the pay scale of Rs.5200-20200 with grade pay of Rs.2400 (Prerevised), admissible under SRO-93 dated 15.04.2009. The candidate is required to report to the Chief Education Officer, Srinagar within Twenty-one (21) days from the date of issuance of this appointment order for seeking further posting on her own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities.

The provisional appointment shall be subject to the following conditions:-

- A) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to who a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.
- B) The verification of qualification certificates/rserved category certificate (wherever applicable) from the concerned issuing authority.

The Chief Education Officer, concerned shall allow the candidate to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such order shall be drawn.

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the acton of his /her migration, in terms of the agreement executed by each appointee under SRO-412;

The seniority of the appointee shall be fixed at the places on the posts of their first appointment in that particular grade/service and the provisional appointees shall be on probation initially for a period of Two years.

The provisional appointment of candidate is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court which are not immediately within the knowledge of this Directorate.
