Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 17.04.2017 forwarded the selection list of Two-hundered Three (203) candidates selected as Teachers, for District Cadre Srinagar under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmiri Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/1206-12 dated 25.01.2017 and No. SSB/Secy/Sel/2017/1213-20 dated 25.01.2017 against Notification No. 01 of 2012 dated 19.07.2012, Item No. 037;

Whereas, vide various notifications issued through Information Department, these selectees were informed to submit the requisite papers in the Directorate of School Education Kashmir within a stipulated time and accordingly provisional appointment orders were issued in their favour;

Whereas, as many as **Twenty-two (22)** candidates in District Cadre Srinagar and **Four (04)** candidates in District Cadre Baramulla failed to submit their papers in response to various notifications issued from time to time by the Directorate;

Whereas, the matter was taken up with the Administrative Department vide this office letter No. Estt-III/B-Trs/7529 dated 21.11.2017 and in turn the Administrative Department vide communication No. Edu-I/77/2017 dated 08.01.2018 conveyed approval for operating waiting list against the slots which become available after giving final opportunity to all such candidates who failed to join the Department so far;

Whereas, in pursuance to the instructions of the Administrative Department, all these **Twenty-six (26)** candidates were given final opportunity vide this office notice No. DSEK/Estt/III/B-Trs/PMP/017/381-83 dated 03.02.2018, for submission of their papers, failing which it shall be presumed that they are not interested to join the Department and the resultant slots shall be filled from the wait list, without any further notice;

Whereas, in response to the final notice, only one candidate namely Ravinder Haku S/O Lt J N Haku R/O Malyar Haba Kadal Srinagar figuring at S.No. 136 in District Cadre Srinagar submitted his documents for issuance of provisional appointment order in his favour, and rest Twenty-five (25) candidates showed no response and failed to deposit the requsite papers within the stipulated time period;

Whereas, in response to another notification dated 03.02.2018, **AMIT SARAF S/o BINARI LAL SARAF** deposited his documents for issuance of provisional appointment order in his favour. However, as per the documents, the parentage has been reflected as **BIHARI LAL**, which needs clarification from the SSB/Administrative Department;

Whereas, the SSB vide letter No. SSB/Secy/Sel/2018/2179 dated 22.02.2018 issued clarification with regard to Marks variation in respect of Suhail Koul S/o Bushan Lal Koul figuring at S.No. 77 in District Cadre Srinagar;

Now, therefore, sanction is hereby accorded to the provisional appointment of **Two (02) candidates** (whose full particulars are reproduced below) as **Teachers** in **District Cadre Srinagar** against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants as per the Annexure to this order in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under–Graduates respectively, admissible under SRO-93 dated 15.04.2009.
