The appointees shall be allowed to join only on production/checking/verification of the following certificates in original.

1. Academic/Technical Qualification certificates.

2. Matriculation/Date of Birth certificates.

3. Health Certificate from the concerned Chief Medical Officer of the District.

4. Permanent Resident Certificate issued by the Competent Authority.

5. Migration certificate being of Kashmir Migrant duly issued by the Relief & Rehabilitation Commissioner (Migrants)

6. Category certificate (if any)

7. Certificates from the District Industries Centre (DIC) and District Employment and Counselling Centre to the effect that no loan under the self employment scheme has been taken by the appointee..

The appointment of the above candidates shall further be subject to the following condition that:-

- (i) Each appointee shall execute an agreement in the "form "prescribed under Jammu and Kashmir Migrant (Special Drive) Recruitment Rules, 2009, issued under notification SRO 412 of 2009 dated 30/12/2009;
- (ii) Each appointee shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his/her academic/technical/category certificates wherever applicable and also character and antecedents is received from concerned issuing agencies/Inspector General of Police (CID)to whom a reference shall be made by concerned within whose jurisdiction he/she is posted, he/she shall have no right to claim his/her appointment as "Junior Assistant" as such shall be deemed to have been cancelled ab-initio.

(iii) If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

(iv) Salary of the appointee shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K and verification of relevant certificate/documents is received from the concerned authorities.

(v) The appointment order shall be governed under new pension scheme as per SRO-400 dated 24/12/2009

- (vi) The appointment of the candidates as "Junior Assistants" shall be subject to outcome of the writ petition(s) if pending any court of law, which may not be immediately within the knowledge of this Directorate.
- (vii) The inter-se seniority of the appointees shall be in the order in which their names appear in the select list furnished by the J&K Service Selection Board.

(viii) The appointees shall be on probation for a period of 02 years.
