Sanction is hereby accorded to the temporary appointment of Sheema Hamid D/o Hamidullah Rather & Fahmida Akhter deceased Teacher, MS Larkipora Zone Dooru District Anantnag R/o Luckbawan Larkipora Tehsil Dooru District Anantnag Qualification: B.Tech. as Laboratory Assistant, in the Pay Level-2 (19900-63200) against an available post in GHSS Dooru District cadre Anantnag on compassionate grounds under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer Anantnag within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:-

- 1. Academic Qualification Certificate.
- 2. Date of Birth Certificate.
- 3. Health Certificate from the concerned Chief Medical Officer of the District.
- 4. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- 5. All other relevant documents as are required under SRO-43/1994.

The appointment of the candidate shall further be subject to the following conditions:

- i. that she shall give an undertaking in the shape of an affidavit to the effect that "If, on verification, genuineness of the qualification certificates and other certificates/documents from the concerned issuing authority is found fake/forged, the appointment made shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her."
- ii. the salary of the appointee shall not be drawn and disbursed to her, unless a satisfactory report in respect of (i) above are received in her favour from the issuing authority.
- iii. the appointee shall be initially on probation for a period of two years.
- iv. the appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009 dated 24-12-2009.
- v. if the appointee fails to join within a period of 21 days from the date of issuance of this order she shall cease her right of appointment which shall be deemed to have been cancelled ab-initio without any further notice.
