Whereas, the Administrative Department vide Communication No. Edu/I/86/2019 dated: 09/05/2019, conveyed the selection list of 1036 candidates as "General Teacher" in various District Cadres of Kashmir Division in terms of SRO-202 of 2015 dated 30.06.2015 pursuant to their selection made by the J&K Services Selection Board;

Whereas, among others, the selection in respect of **Thirty-seven (37) candidates** was kept withheld by the SSB for want of certain clarification, which has now been released vide various communications of SSB as conveyed by Administrative Department vide Communication No. Edu-I/86/2019-II dated 28.09.2020 and No. Edu-I/86/2019-II dated 29.09.2020.

Whereas, upon examination of the issue, it revealed that provisional appointment order can be considered only in respect of 15 candidates (Fourteen from selection zone and One from waiting list against whom slot has already been accrued due to non-joining of One candidate in the respective Category/District) leaving 22 candidates which still figure in the waiting list;

Now, therefore, on the basis of recommendations of JKSSB and instructions of the Administrative Department, sanction is hereby accorded to the Provisional appointment of Fifteen (15) candidates as "General Teacher" in District Cadre Budgam (04)/Kulgam (03)/Pulwama (02)/ Shopian(01)/ Baramulla (03) & Srinagar (02) as per Annexure to this order in the in the Pay Level 5 (Rs. 29,200/-92,300/-) under SRO-202 of 2015 dated 30.06.2015, amended vide S.O. 194 dated 17.06.2020 against the available slots, subject to the final outcome of the cases, if any, pending before any Hon'ble Court:

The appointment of these candidates as "General Teacher" is subject to the following conditions:-

- I. The condition of probation, pay and allowances and fixation of initial tenure of the appointee shall be governed by Jammu & Kashmir Probationer (Conditions of Service, Pay & Allowances) and Fixation of Tenure Rules, 2020 issued vide S.O. 192 of 2020 dated 17.06.2020 read with Government Order No. 654-JK(GAD) of 2020 dated 19.06.2020The appointees shall be governed under New Pension Scheme as per SRO 400 of 2009 dated 24.12.2009.
- II. In case, at any stage it emerges that the certificates/any relevant document furnished/produced by the selectee is/are fake/fictitious, the appointment order shall be cancelled ab-initio and criminal proceedings shall be initiated against the candidate and to this effect the provisional appointee shall give an undertaking by way of affidavit duly attested by the 1st Class Judicial Magistrate;
- III. The appointees shall give an undertaking by way of affidavit duly attested by the 1st Class Judicial Magistrate to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.
- IV. The appointees shall give an undertaking in shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled ab-initio and he/she shall have no claim of his/her appointment'

V. The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.

The appointees shall report to the concerned Chief Education Officers within a period of 21 days from the date of issuance of this appointment order for seeking further posting orders on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities. In case of failure to join within stipulated time period, the appointment shall be deemed to have been cancelled ab-initio without any further notice.

The candidates who fail to join within a period of 21 (Twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice in light of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated: 04/12/2019.

The Chief Education Officer, concerned shall allow the candidates to join on the posts after observing all the conditions of appointment order as reflected at Para 07 and after verifying the following certificates (in original):

- Character and antecedents certificate from Additional Director General of Police (CID)
- *Qualification certificate viz Degree/Marks*
- Permanent resident certificate
- Physical fitness certificate
- Date of birth certificate
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-Self Employment Scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority in order to ensure that the qualifications as reflected in the selection list is according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary shall be drawn till issuance of confirmation order.

The inter-se seniority of the appointees in the particular grade/service shall be fixed giving due consideration to their inter-se merit in the selection in terms of Rule 24 of CCA Rules, 1956.
