The appointment of the appointee shall further be subject to the following conditions:-

- (a) That she shall give an undertaking in the shape of an affidavit duly sworn in before Judicial Magistrate to the effect that:-
 - (i) If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Class-IV shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.
- (b) The salary of the appointee shall not be drawn and disbursed to her, unless a satisfactory report in respect of (i) above is received in her favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009 dated 24-12-2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order she shall cease her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
