Whereas; Administrative Department vide letter No. Edu-NG K/106/2021-01-SED dated 27/08/2021 had forwarded the select list of 05 candidates (**RBA=02, SC=02, ST=01**) for the post of "Junior Assistant" in School Education Department District cadre Anantnag item No. 268 (03 of 2016, dated 30/06/2016) issued by the Secretary Jammu and Kashmir Service Selection Board, Jammu vide letter No. SSB/Sel/Secy/PC/14/2021/5082-88 dated 19/07/2021;

Whereas, this Directorate has issued a notification vide No. DSEK/NT/SSB/ 608/2021/JA/1532-33 dated 01/10/2021 in respect of 04 out of 05 candidates in District cadre Anantnag (except those whose recommendation has been kept withheld by the J&K Service Selection Board) and published in daily newspaper Srinagar Times on 04/10/2021 directed them to submit their Character and Antecedent Rolls in triplicate as per the Govt. order No. 528-JK (GAD) of 2021 dated 21/06/2021;

Whereas; this office has forwarded their requisite documents as laid down in the Government Order No. 528-JK (GAD) of 2021 dated 21/06/2021 to Additional Director General of Police J&K (CID) Srinagar vide this office letter No. DSEK/NT/SSB/608/2021/JA/1633 dated 16/10/2021 with regard to obtaining of verification of Character and Antecedents reports in respect of them;

Whereas, this Directorate has received their Character and antecedents reports issued by the Dy. Supdt of Police, Hqrs) CID J&K (VB) bearing their official communication Nos. CID/VB/2021/Final/50630-636/Edu dated 24/Dec/2021, No. CID/VB/2021/Final/50630-636/Edu dated 22/Dec/2021 and No. CID/VB/2022/Final/50630-636/Edu dated 15/03/2022

Whereas, due to non-availability of clear vacancies of Junior Assistants the matter was taken up the matter with the Administrative Department vide letter no. DSEK/NT/ SSB/608/ 2021/JA/1154 dated 26/07/2021 with several reminders vide No. DSEK/NT/SSB/574/2019/Bpr/Jr.Asstt/1913/14 dated 13/11/2021, No. DSEK/NT/SSB/608/2021/JA/173 dated 21/01/2022, No. DSEK/NT/SSB/6082021/JA/545 dated 03/03/2022, No. DSEK/NT/SSB/608/2021/JA/700-01 dated 16/03/2022, No. DSEK/NT/SSB/608/2021/JA/1113 dated 28/04/2022, No. DSEK/NT/SSB/608/2021/JA/2170 dated 30/05/2022 and No. DSEK/NT/SSB/608/2021/JA/2183 dated 04/06/2022 with regard to resolutions of the issue;

Whereas; the Administrative Department vide letter No. Edu/42/2022-01-SED dated 18/07/2022 instructed to issue appointment orders in respect of **04 candidates** for the post of Junior Assistant District cadre, Anantnag selected vide SSB's recommendations bearing No. SSB/Sel/Secy/PC/14/2021/5082-88 dated 19/07/2021, after fulfilment of requisite Codal formalities;

Whereas; pursuant to the selection made by the J&K Service Selection Board, Jammu and conveyed by the Administrative Department vide above referred communication, sanction is hereby accorded to the provisional appointment of below named four candidates (whose particulars are reflected against them) as "Junior Assistant" in District cadre Anantnag under RBA=02, SC=02 category in pursuance to SSB's advertisement Notice No. 03 of 2016 dated 30/06/2016 in the minimum of Pay Level 4 (25500-81100/-). **The condition of probation, pay and allowances and fixation of initial tenure of the appointee shall be governed by Jammu & Kashmir Probationer (Condition of Service, Pay & Allowances) and Fixation of Tenure Rules 2020 issued vide S.O 192 of 2020 dated 17/06/2020.**

The appointment of the candidates as "Junior Assistant" is subject to the following conditions:-

- I. The appointees shall be governed under New Pension Scheme as Per SRO 400 of 2009 dated 24/12/2009.
- II. In case, at any stage it emerges that the certificates/any relevant document furnished /produced by the selectee is/are/fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate and to this effect the provisional appointee shall give an undertaking by way of affidavit duly attested by the 1st Class Judicial Magistrate;
- III. The appointees shall give an undertaking by way of Affidavit duly attested by the 1st Class Judicial Magistrate to the effect that they will not apply for transfer in any case for whatsoever reasons during the temporary service from the place where they have been adjusted/posted.

The appointees shall report to the Chief Education Officer, Anantnag within a period of 21 days from the date of issuance of this appointment order for seeking further posting orders. In case of failure to join within stipulated time period, the appointment shall be deemed to have been cancelled abinitio without further notice in terms of the circular instructions issued by GAD vide No. 08-JK (GAD) of 2019 dated 04/12/2019;

The Chief Education Officer, Anantnag shall allow the candidates to join on the post after observing all the conditions of appointment order and after verifying the following certificates (in original)

- All Academic/Technical Qualification certificates.
- Domicile Certificate
- Category Certificate.
- Age and health certificate.
- Discharge certificate from the Institution attending / last attended.
- Certificate from District Industries Centre/Employment Exchange to the effect that no loan under self-employment scheme has been taken.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority in order to ensure that the qualifications as reflected in the selection list is according to the genuineness marks card/qualification certificate.

The inter-se seniority of the appointee in the particular grade/service shall be fixed giving due consideration to their inter-se merit in the selection list in terms of Rule 24 CCA Rules, 1956.

This order is issued without prejudice to any writ petition(s)/suit(s), if any, pending before the Hon'ble High Court or any other court of Law or any order which may not be presently within the knowledge of this Directorate.


