Whereas, the Admn. Deptt. vide letter No. Edu-I/615/2018, dated. 20/08/2018, read with No. Edu-I/522/2018, dated. 06/09/2018 has forwarded the selection list of 80 (eighty) Jr. Assistants, District Anantnag=05 (RBA=03, SC=02), Bandipora=03 (RBA 01, SC=01, ST=01), Baramulla=29 (OM=10, RBA=12, SC=06, OSC=01), Budgam=07 (RBA=03, SC=03, ST=01), Kupwara=30 (OM=16, RBA=09, SC=04, ST=01), Pulwama=02 (RBA=01, SC=01), Shopian=02 (SC=01, ST=01) and Srinagar =02 (SC=02), issued by the J&K Service Selection Board Srinagar, vide letter No. SSB/Secy/Sel/2018/8075-81, dated. 11/07/2018, No. SSB/Secy/Sel/2018/7737-43, dated. 06/07/2018, No. SSB/Secy/ Sel/2018/8089-95, dated. 11/07/2018, No. SSB/Secy/Sel/2018/8124-30, dated. 11/07/2018, No. SSB/Secy/Sel/2018/7737-43, dated. 06/07/2018, No. SSB/Secy/Sel/ 2018/8229-35, dated. 11/07/2018, No. SSB/Secy/Sel/2018/8285-91, dated. 11/07/2018, and No. SSB/Secy/Sel/ 2018/8304-8310, dated. 11/07/2018, respectively;

Whereas the appointment order in respect of 76 selectees (except those in whose favour recommendation is kept withheld by J&K Service Selection Board for want of certain clarification) was issued vide order Nos. 1162-DSEK of 2018, dated. 10/09/2018, order No. 1271-DSEK of 2018, dated. 06/10/2018 and order No. 187-DSEK of 2019 dated 06/02/2019 respectively;

Whereas the withheld recommendation of two (02) candidates namely Shabir Ahmad Sheikh and Shabir Ahmad War under RBA category in District cadre Kupwara, out of remaining 04 (four) selectees, has been released by J&K Service Selection Board Jammu, conveyed by Admn. Deptt. vide letter No. Edu-I/615/2018, dated. 14/02/2019. Accordingly this office issued appointment order vide No. 354-DSEK of 2019 dated 01/03/2019 in their favour, published in daily Tamil Irshad on 06/03/2019, directing the appointees to report the concerned CEO, within 21 days from the date of issuance of the order, for seeking further posting on their own risk and responsibility till the verification/ authentication of all relevant Documents /Certificates is received from the concerned issuing agencies;

Whereas, pursuant to the appointment order issued vide No. 354-DSEK of 2019, dated 01/03/2019, Mr. Shabir Ahmad Sheikh S/O Ali Mohammad Sheikh R/O Oapazwani Sirrajpoora Handwara Kupwara selected under RBA category figuring at SSB S.No. 04 has not reported to the Chief Education Office Kupwara, within the stipulated period;




