Whereas, the Admn. Deptt. vide letter No. Edu-I/367/2018, dated. 25/04/2018, has forwarded the selection list of 10 (ten) Laboratory Assistants, under open merit category in District cadre Srinagar issued by the J&K Service Selection Board Jammu, vide letter No. SSB/Secy/Sel/2018/1842-48 dated: 19/02/2018 under Hon'ble Prime Minister Special Package for Kashmiri Migrants;

Whereas, the appointment order of selectees (except those in whose favour recommendation is kept withheld by J&K Service Selection Board for want of certain clarification) has been issued vide order No. 355-DSEK of 2019, dated. 01/03/2019 and published in Press through information Department appeared in Rising Kashmir, on 06/03/2019, directing the appointees to report the Chief Education Office Srinagar within 21 days from the date of issuance of the order, for seeking further posting on their own risk and responsibility till the verification/ authentication of all relevant Documents/Certificates is received from the concerned issuing agencies;
