Whereas, Fifteen (15) candidates were provisionally appointed as "General Teacher" in various District Cadres of Kashmir Division vide Order No. 385-DSEK of 2020 dated 16.11.2020 in pursuant to their selection made by the JKSSB as conveyed by the Administrative Department's communication No. Edu-I/86/2019 dated 09.05.2019;

Whereas, these provisional appointees were required to report before the concerned Chief Education Officers within a period of 21 days from the date of issuance of the provisional appointment order for seeking further adjustment in the respective districts;

Whereas, after expiry of the stipulated time period of 21 days, the Chief Education Officer Baramulla/Budgam/Pulwama/Shopian communicated the particulars of Five (05) candidates vide above referred communications, who failed to join on the posts of "General Teacher" for which they were appointed in the Department vide Directorate's Order No. 385-DSEK of 2020 dated 16.11.2020;

Whereas, in light of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated: 04/12/2019 the candidates who fail to join within a period of Twenty one (21) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

Now, therefore, the provisional appointment order of the below mentioned Five (05) candidates issued vide this office Order No. 385-DSEK of 2020 dated 16.11.2020 is hereby cancelled ab-initio:-
