- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed).
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.

Whereas, in light of above instructions of the Administrative Department Ms Shaheena Bashir D/o Bashir Ahmad Baba R/o Ganai Pora Mattan, Anantnagfurnished her undertaking on the devised format duly attested by the 1st Class Magistrate alongwith all original certificates, in response to this office notification No. Estt-III/B-Trs/66275-78 dated 22.12.2015.



Now, therefore, sanction is hereby accorded to the provisional appointment of Ms Shaheena Bashir D/o Bashir Ahmad Baba R/o Ganai Pora Mattan, Anantnag (whose full particulars are reproduced below) as Teacher District Cadre Anantnag against the available slot in OM categoryin the pay scale of Rs.5200-20200 with grade pay of Rs. 2800 and 2400 for Graduates and above and Under–Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidateis required to report to the Chief Education Officer, Anantnag by or before 25th January, 2016 for further posting.

- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.
