- 2. That the incumbents have completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in Rule 4(k) of SRO-14 dated 15.01.1996;
- That the incumbents were not under suspension or contemplated in any charge or charge- sheet under Classification Control and Appeal Rules 1956 or any other rules and their work and behaviour have remained satisfactory; 3.
- That the present promotion In-Situ shall not change / affect the existing designation / seniority/ duties of the employees; 5. That the benefit of the In-Situ Promotion shall not be applicable, if the official who has earlier foregone regular/functional
- promotion or will forego their functional promotion in future; 6.
- That before implement the order, the concerned CEO/DDO shall ensure that the employees are holding genuine appointment on substantive basis in school Education Department, before implement this order;
