Sub: Probing of 10th pass certificate as fake and fabricated -- termination of service thereof.

Order No: 563- DSEK of 2022

Whereas, **Mtr. Neelofar Manzoor D/o Manzoor Ahmad Rangrez** R/o Rohama Baramulla was engaged in the Department as Education Volunteer in EGS Centre (Alsafa Colony A) on the basis of 10th pass certificate, by the Zonal Education Officer Rohama on **18/07/2005**; and

Whereas, after passing 10+2 examination through Bhartiya Shiksha Parishad UP on **15/06/2011**, she was converted as ReT in PS Gujjerpati Zone Rohama by the Chief Education Officer Baramulla w.e.f 15/06/2011 vide order issued under No. CEO/Bla/EGS/PS/MS/UPG/Plg/15743-89 dated: 12/05/2018; and

Whereas, the Chief Education officer Baramulla submitted the case file of the said incumbent to this office for regularization of service after completion of 05 years as ReT; and

Whereas, upon examination of the case it was found that the said incumbent has passed 10th class examination through JKBOSE under Roll No. 340407 session 2000 and accordingly the said certificate was sent for verification to the JKBOSE; and

Whereas, this office received two contradictory verification reports from the JKBOSE on 30/03/2022 and 25/05/2022, which created chaos and confusion and thereafter both the verification reports were sent to the Board authorities for its authenticity on 22/06/2022 by this office; and

Whereas, Joint Secretary, Verification KD, JKBOSE vide communication No. F (JS-Ver)B/KD/2022/R-3085/ASV Dated: 30/06/2022 conveyed that the the said 10th class marks certificate of the incumbent is **FAKE** and **FABRICATED** and also conveyed that the earlier verification report dated: 25/05/2022 has neither been signed nor issued by their office; and

Whereas, a notice was also served to the said incumbent **Mtr. Neelofar Manzoor** by this office on 19/04/2022 for explaining her position for producing fake and fabricated certificate which she responded and denied all the charges leveled against her; and

Whereas, the Joint Director (EE), DSEK was nominated as Enquiry Officer to conduct full dress enquiry into the said case and was requested to submit findings of the enquiry with his recommendations; and

Whereas, the Joint Director (EE), DSEK furnished the enquiry report on 09/09/2022 and established that the said marks certificate of 10th class examination bearing Roll No. 340407 session 2000 is **FAKE** and **FABRICATED** and recommended that the orders for termination of services of the said delinquent official be issued; and

Now, therefore; in light of the recommendations of the Enquiry officer (Joint Director (EE), DSEK), the services of **Mtr. Neelofar Manzoor D/o Manzoor Ahmad Rangrez** District Baramulla presently working as ReT in PS Gujjerpatai Zone Rohama District Baramulla are hereby terminated with immediate effect.
