Disciplinary action or proceedings if and when warranted, shall be conducted consistent with the due process of law and also notified to the CEO/ZEO concerned,
- VIII. Deposit with the respective office due share/ subscription on account of Games / Red cross fund in terms of the orders / instructions in force.
- IX. Furnish correct and complete information as per format provided to CEO/ZEO concerned for updation of District Information System of Education (DISE) and Education Management Information System (EMIS) against proper official receipt,
- X. The school authority shall apply for approval of the Managing Body within a period of one month from the date of issuance of this order.

Any deviation or default in adherence to the norms/rules laid down and the orders / instructions issued from time to time shall render the School liable for strict action which may include withdrawal of fecografion, under law/rules.
