Whereas, the Administrative Department vide letter No. Edu-I/287/2014 dated 13.08.2014 forwarded the list of **563** candidates selected as Teachers for District cadre **Kupwara**, pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/014/6328-34, dated 23.07.2014;

Whereas, among these 563 candidates, the slots at S.No. 142, 168, 270, 09/Wait, 36/Wait under OM Category and 51 and 106 under RBA Category were kept blank by the SSB for want of certain clarification with regard to equivalence of their degrees with that of the degrees awarded by J&K BOSE/University of Kashmir;

Whereas, the Administrative Department vide letter No. Edu-I/287/2014-II dated 13.10.2016, forwarded SSB's Order No. 1313-SSB of 2016 dated 31.08.2016 whereunder the recommendation against these blank slots at S.No. 142, 168, 270, 09/Wait, 36/Wait under OM Category and 51 and 106 under RBA Category have were released in favour of the Seven (07) candidates for further necessary action, under rules;

Whereas, the above order of SSB dated 31.08.2016 reveals that with regard to eqvilanece of 10+2, Graduation & B.Ed , the clarification was sought by the SSB vide their communication SSB/Sel/Secy/14/7910 dated 03.09.2014, No. SSB/Sel/Secy/2014/5140-41 dated 17.06.2014 and No. SSB/Sel/Secy/14/3634-035 dated 30.12.2014;

Whereas, in response, the School Education Department has intimated vide letter No. Edu/NC/SE/411/2013 Part-II dated 11.04.2016 as under:-

Whereas, in response to the Notification dated 03.11.2016, all the Seven (07) selectees submitted their undertakings alongwith original testimonials, for issuance of provisional appointment order, in pursuance to their selection made by the Services Selection Board vide communication referred to above.

Whereas, after examination of the documents, some discrepancy with regard to Marks variation in 10+2 (533/700 by SSB and 488/600 reflected in the Marks certificate) in respect of Sajjadur Rahman S/o Abdur Rahman figuring at S.No. 168 in the SSB's select list under OM/RBA Category were observed;

Whereas, the matter was taken up with the Administrative Department and Secretary Services Selection Board vide letter No. Estt/B-Trs/Sel/1091-92 dated 22.11.2016 with and in reply the Secretary Services Selection Board vide communication No. SSB/Sel/Secy/72/2014/3119 dated 17.03.2017 cleard that the marks shown against his 10+2 i.e. 533 out of 700 may be treated as final and the same communication dated 17.03.2017 was authenticated again by SSB vide letter No. SSB/Sel/Secy/72/2014/4910 dated 22.05.2017;

Now, therefore, sanction is hereby accorded to the provisional appointment of Mr. Sajjadur Rahman S/o Abdur Rahman R/o Marhama, Kupwara (whose full particulars are reproduced below) as Teacher in District Cadre Kupwara in the pay scale of Rs.5200-20200 with grade pay of Rs. 2800 and 2400 for Graduates and above and Under–Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidate is required to report to the Chief Education Officer, Kupwara within Ten (10) days from the date of issuance of this appointment order for seeking further posting on his own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned agencies:
