Whereas, the Admn. Deptt. vide letter No. Edu-I/560/2018, dated. 29/08/2018, (read with No. Edu-I/522/2018, dated. 06/09/2018), has forwarded selection list of 05 Library Assistants District cadre Shopian (OM=03, RBA=02) issued by the J&K Service Selection Board Srinagar, vide No. SSB/Secy/Sel/2018/7590-97, dated. 27/06/2018, under SRO 202 of 2015, dated. 30/06/2015, against Notification No. 02 of 2017, dated. 18/10/2017, item No. 089;

Whereas, this office vide order No. 1171-DSEK of 2018, dated. 10/09/2018 has issued provisional appointment to the selectees and got it published in press through Information Department and appeared in daily Kashmir Uzma, on 13/09/2018, directing them to report the Chief Education Office, Shopian within 21 days from the date of issuance of the order, for further seeking posting on their own risk and responsibility till the verification/ authentication of all relevant Documents/Certificates is received from the concerned issuing agencies;

Whereas, in response to the said provisional appointment order only (04) four candidates (OM=02, RBA=02) have joined in CEO's Office Shopian with the requisite qualification certificates and other testimonials as reported by the Chief Education Officer Shopian, vide his office letter No. CEO/Spn/NT/4654, dated. 16/10/2018;

Whereas, Mr Abid Hussain Mir figuring at S.No. 01 in the order though has failed to join before CEO's Office Shopian, within the stipulated period of 21 days but has contrary submitted an affidavit duly sworn in before the Hon'ble Chief Judicial Magistrate, Shopian undertaking that he is not willing to join the Education Department, as he is already working in Estates Department.

Now, therefore, in view of the facts indicated above, the appointment as Library Assistant issued vide order No.1171-DSEK of 2018, dated. 10/09/2018, so far as it relates to Mr. Abid Hussain Mir, S/O Gh. Mohi Ud Din Mir, R/O Kral Check, Berthipora Near Jio Tower, District Shopian, is hereby cancelled ab-initio.


