- 6. Certificate from District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under any self employment Scheme has been taken by the appointee (s).
- 7. Character / antecedents certificates.

If on verification, the certificates produced by the appointee proved to be fake or forged, the appointment shall stand cancelled ab-initio.

The appointment of above candidates shall further be subject to the following conditions:-

- a) That the appointment of the selected candidate is strictly governed under SRO-202 of 2015 dated 30/06/2015.
- b) That the appointee shall submit an undertaking in the shape of an affidavit to the effect that in case adverse report about his Character and antecedent is received from the Additional Director General of Police (CID), J&K to whom a reference shall be made by the Director School Education Department, he/she shall have no right to claim his appointment as Lecturer and his appointment, as such, shall be deemed to have been cancelled ab-initio;
- c) Verification/genuineness of the qualification, reserved category certificates etc. from the concerned issuing authorities.
- d) That salary of the appointee (s) shall not be drawn and disbursed to them unless the satisfactory reports in respect of (b) and (c) above are received in their favour.
- e) That in the matter of ther conditions of service like age, qualification, discipline, conduct and other allied matters, a person appointed under these rules shall be governed by the recruitment rules of the service to which the post occupied by him belongs, besides, other rules, regulations and orders in vogue in the State Civil Services in general.

The appointment shall also be subject to the outcome of the writ petition(s) if any, pending before Hon'ble Court of

Law.
