Whereas, in terms of circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated: 04/12/2019, *the candidates who fail to join within a period of 21 (Twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice*", which was reflected in their appointment orders as well;

Now, therefore, sanction is accorded to the **cancellation** of the provisional appointment order as "**General/Science-Math/Urdu Teacher**" issued vide Order No. 03 DSEK of 2020 & 04 DSEK of 2020 Dated: 07/01/2020 so far as it pertains to **Fifteen (15)** appointees (whose names are reflected at Para 01) ab-initio.
