**Subject:** Mutilation in Date of Birth of Khursheed Ahmad Rather, Master, HSS Hariparigam .

**Order NO:** 78 DSEK of 2023.

Whereas, while scrutinizing the Service Books of the Employees retiring in next three years, the Principal HSS Hariparigam (DDO) Pulwama suspected mutilation in year column of the Date of Birth of Khursheed Ahmad Rather, Master both in figures as well as in words; and

Whereas, in order to rectify the records, the official was asked to produce the Original Date of Birth Certificate by the DDO to authenticate the Date of Birth showed in Service Book as 19.06.1965; and

Whereas, the Date of Birth Certificate submitted by the official was verified by the JK BOSE vide letter No. F(JS-Ver) B/KD/2022/R-6826, Dated:- 31/08/2022 showing the Date of Birth as 19/06/1963; and

Whereas, a committee was constituted by Chief Education Officer, Pulwama vide letter No. CEO/Pul/IMW/22/1528-29, Dated:- 03/10/2022 to conduct an in-depth inquiry into the matter, the inquiry committee submitted its report with the recommendation reproduced as :-

*"After thorough enquiry and after having made conclusion, it is recommended that the Master in question was interrogated and has been found guilty conscience of having being guilty of committed such mistake. As such Master in question be placed under suspension and action as warranted under rule shall be initiated against him"*

Whereas, the Chief Education Officer, Pulwama vide Order No. CEO/Pul/IMW/22/1620-23, Dated:- 15/10/2022 placed the delinquent Master under suspension and attached with ZEO's Office Shadimarg. However the Suspension Order was later on rescinded ab-initio vide this office communication bearing No. DSEK/Estt-III/A-Trs/2917-19, Dated:- 22/10/2022 for lack of competence; and

Whereas, this office vide letter No. DSEK/IMW/Sus/Pul/1961, Dated:- 12/12/2022 requested Chief Education Officer, Pulwama to submit all documents pertaining to the case along with the original Service Book of the delinquent Official. In response the Chief Education Officer, Pulwama vide letter No. CEO/Pul/IMW/23/1074-75, Dated:- 18/01/2023 submitted Original Service Book of the official which reveals visible mutilation in the year column of Date of Birth and does not match with verification report issued by the JK BOSE.

Now therefore, in view of the facts enumerated above and as recommended by the designated enquiry committee, Mr. Khursheed Ahmad Rather, Master, HSS Hariparigam is placed under suspension with immediate effect.
