Subject:-O.A./62/1263/2021 titled Mohammad Aslam Naik V/s Union Territory of J&K.

**ORDER NO. 781 -DSEK of 2021
DATED : 01 / 11 / 2021**

Whereas, Administrative Department vide communication No. Edu/I/86/2019 dated 09/05/2019 forwarded list of candidates recommended by JKSSB for the post of "General Teacher" various Districts of Kashmir Division including 46 candidates in District Cadre Shopian as communicated vide JKSSB's No. SSB/Secy/Sel/45/2019/1693-99 dated 08.03.2019; and

Whereas, accordingly, provisional appointment orders were issued in respect of all such candidates against whom recommendations were not kept withheld by JKSSB and were free from all encumbrances; and

Whereas, after issuance of appointment orders, Two slots accrued due to non-joining of two of candidates (under OM Category) against "General Teacher" in District Cadre Shopian and wait list was accordingly operated vide this office Order No. 822-DSEK of 2019 dated 25.11.2019; and

Whereas, Two more slots accrued under OM Category in District Cadre Shopian against "General Teacher" post in pursuance to order No. 272-DSEK of 2020 dated 29.06.2020 and No. 462-DSEK of 2020 dated 31.12.2020, however waiting list could not be operated upon in respect of these Two slots due to the fact that the selection/wait list lost its validity of one year on 08.03.2020; and

Whereas, aggrieved due to non-operation of waiting list against the accrued slots, the Petitioner approached the Hon'ble Central Administrative Tribunal, Jammu Bench through the medium of O.A./62/1263/2021 titled Mohammad Aslam Naik V/s Union Territory of J&K; and

Whereas, vide Order dated 24.08.2021, the Hon'ble Central Administrative Tribunal, disposed of the O.A. and directed as under:-

"In view of the submissions made by learned counsel for the applicant the O.A. is disposed of with a direction to the respondents to treat this O.A. as a representation of the applicant and consider the case of the applicant for appointment to the post of General Line Teacher on the basis of waiting list, if any in operation and pass a reasoned and speaking Order within a period of six weeks from the date of receipt of a certified copy of the order"

Whereas, in compliance to the directions of the Hon'ble Central Administrative Tribunal, the case of the Petitioner has been examined thoroughly with the relevant records and it came to fore that the validity of select/wait list stand expired on 08.03.2020 as such wait list cannot be operated upon at this later stage.

Now, therefore, in compliance to the Hon'ble Central Administrative Tribunal Order dated 24.08.2021, the representation of the Petitioner with regard to operation of waiting list and issuance of appointment order beyond its validity period is considered and rejected as the select/wait list has already lost its validity on 08.03.2020 and waiting list is not operative as on date.


