Sub: Un-authorized absence case of Smt.Rachna Bhat, Teacher MS Krangsoo Anantnag and withdrawal of show cause notice thereof.

Whereas, the Chief Education Officer Anantnag vide his communication dated 28/12/2020 reported that Smt.Rachna Bhat Teacher MS Krangsoo Anantnag remained un-authorizedly absent from duties w.e.f. 01/09/2017 to 13/06/2019; and

Whereas, on 14/06/2019 the said absconding teacher was allowed to resume her duties without obtaining prior permission from the competent authority; and

Whereas, after obtaining a report from the concerned sub-office, it was communicated that the following Officer/officials were involved in allowing the absconding teacher to resume her duties after a gap of near about 02 years without obtaining prior permission from the competent authority;

Whereas, a show cause notice was served to all the three officer/officials wherein they were asked to explain their position as to why and under which circumstances they allowed the teacher to resume her duties without obtaining prior permission from the competent authority;

Whereas, the Chief Education Officer Anantnag vide his communication dated: 07/10/2021 forwarded the reply of the above mentioned Officer/officials to this office for taking further necessary action in the matter;

Whereas, after examining the reply of these Officers/officials it was found that the present ZEO Mattan mis-communicated with regard to the particulars of the DDO who allowed the said teacher to resume her duties on 14/06/2019 and observed that **Mtr. Eras Andleeb the then DDO** of the office is not involved for the same as she assumed the charge of ZEO Mattan on 02/09/2019, whereas the teacher was allowed on 14/06/2019;


