Whereas, Mtr. Sadaf Shareen was appointed in the Department as Teacher in District Cadre Srinagar on 12/06/2009 for a probation period of two years and subsequently posted in BMS Hazratbal; and

Whereas, the incumbent remained un-authorizedly absent from her legitimate duties w.e.f 01/08/2015;

Whereas, the teacher was served several notices by the Drawing & Disbursing officer on 16/06/2016 and by this Directorate on 15/06/2017 to resume her legitimate duties, which she failed;

Whereas, she was provided one more opportunity by this office on 06/07/2021 through a joint show cause notice wherein she was asked to present herself before this Directorate along with written statement of defence within a period of 15 days from the issuance of notice failing which action as warranted under Article 128 & Article 113 of J&K CSR Vol-I of 1956 shall be taken;

Whereas, the teacher failed to present herself before this Directorate with the statement of defence and accordingly the issue was placed before the Designated Committee and the committee passed the following decision:

"Initiate action under Article 113 & 128 of J&K CSR Vol-I of 1956 against the said teacher with continuously absconding from more than 05 years;

Whereas, remaining un-authorizedly absent from duties more than 05 years attracts action as warranted in terms of Article 128 & 113 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-

Article 128

'Absence without leave or after the end of leave involves loss of appointment' Article 113

"After five years of continuous absence on leave an officer is considered to be out of state employee."

Now, therefore, Ms. Sadaf Shireen, Teacher BMS Hazratbal, Srinagar is hereby removed from Government service in terms of Article 113 of J&K Civil Services Rules (Volume I) of 1956 read with Rule 30 (vii) of J&KCCA Rules of 1956.
