- 5) That this permission shall be deemed to be cancelled ab-initio, if at any stage, it is established that the degree(s) acquired by the ReT is/are fake or have been obtained through tuck shops/un-recognized University/Institution or if the degree is not recognized as an equivalent degree for the benefit claimed or reaped by incumbent.
- 6) That the authenticity/genuineness of academic certificates has been ascertained/established by the CEO/DDO discreetly and the CEO/DDO shall be personally responsible for genuineness/legality and validity of the certificate.
- 7) The CEO/DDO shall ensure that the qualification has not been acquired through regular mode when candidate was on the establishment of School Education Department.
